COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASSES ACT, 1993 (ACT NO.130 OF 1993), AS AMENDED

ANNUAL INCREASE IN MEDICAL TARIFFS FOR MEDICAL SERVICES PROVIDERS.

- I, Thembelani Waltermade Nxesi, Minister of Employment and Labour, hereby give notice
 that, after consultation with the Compensation Board and acting under powers vested in me
 by section 97 of the Compensation for Occupational Injuries and Diseases Act, 1993 (Act
 No.130 of 1993), prescribe the scale of "Fees for Medical Aid" payable under section 76,
 inclusive of the General Rule applicable thereto, appearing in the Schedule, with effect from
 1 April 2023.
- 2. Medical Tariffs increase for 2023 is 4%
- The fees appearing in the Schedule are applicable in respect of services rendered on or after
 April 2023 and Exclude 15% Vat.

GENERAL INFORMATION ABOUT THE COMPENSATION FUND AND ITS MEDICAL SERVICES BENEFITS DIRECTORATE

THE EMPLOYEE AND THE MEDICAL SERVICE PROVIDER

Medical Service Providers are advised to take note of the following as it pertains to the treatment of patients in relation to the Compensation for Occupational Injuries and Diseases Act of 1993 (COID Act):

- An employee as defined in the COID Act of 1993, is at liberty to choose their preferred medical service provider and no interference with this is permitted, as long as it is exercised reasonably and without prejudice to the employee or the Compensation Fund.
 The only exception to this rule is in case where an employer, with the approval of the Compensation Fund, provides comprehensive medical aid facilities to his employees, i.e. including hospital, nursing and other services section 78 of the Compensation for Occupational Injuries and Diseases Act refers.
- In terms of section 42 of the COID Act of 1993, the Compensation Fund may refer an injured employee to a specialist medical practitioner designated by the Director General for a medical examination and report. Special fees are payable when this service is requested.
- In terms of section 76,3(b) of the COID Act of 1993, no amount in respect of medical expenses shall be recoverable from the employee.
- In the event of a change of a medical practitioner attending to a case, the first treating doctor
 in attendance will, except where the case is transferred to a specialist, be regarded as the
 principal treating doctor.
- To avoid disputes regarding the payment for services rendered, medical practitioners should refrain from treating an employee already under treatment by another doctor without consulting / informing the principal treating doctor. As a general rule, changes of doctor are not favoured by the Compensation Fund, unless sufficient reasons exist for such a change.
- According to the National Health Act no 61 of 2003, Section 5, a health care provider may not
 refuse a person emergency medical treatment. Such a medical service provider should not
 request the Compensation Fund to authorise such treatment before the claim has been
 submitted to and liability for the claim is accepted by the Compensation Fund.
 - Pre-authorisation of treatment is not possible and no medical expense will be approved if liability for the claim has not been accepted by the Compensation Fund.
- An employee seeks medical advice at their own risk. If such an employee presents themselves
 to a medical practitioner as being entitled to treatment in terms of the COID Act of 1993,
 whilst having failed to inform their employer and/or the Compensation Fund of any possible
 grounds for a claim, the Compensation Fund cannot accept responsibility for the settlement
 of medical expenses incurred.
- The Compensation Fund could also have reasons to repudiate a claim lodged with it, in such
 circumstances the employee would be in the same position as any other member of the public
 regarding payment of his medical expenses.



- Proof of identity is required in the form of a copy of a South African Identity document/card,
 will be required in order for a claim to be registered with the Compensation Fund.
 - o In the case of foreign nationals, the proof of identity (passport) must be certified.
- All supporting documentation submitted to the Compensation Fund must reflect the identity and claim number of the employee.
- The completion of medical reports cannot be claimed separately as they are inclusive in all medical tariffs.
- The tariff amounts published in the gazette guides for medical services rendered in terms of the COID Act do not include VAT. All invoices for services will therefore be assessed without VAT.
- VAT will therefore be calculated and applied without rounding off to invoices for service providers that have confirmed their VAT vendor status with the Compensation Fund by the submission of their VAT registration number.

POPI COMPLIANCE

In terms of Protection of Personal Information Act, 2013 (POPI Act), the Compensation Fund wants to assure Employees and the Medical Service Providers that all personal information collected is treated as private and confidential. The Compensation Fund has put in place the necessary safeguards and controls to maintain confidentiality, prevent loss, unauthorized access and damage to information by unauthorized parties.



OVERVIEW OF CLAIMS PROCESS WITHIN THE COMPENSATION FUND

All claims lodged in the prescribed manner with the Compensation Fund follow the process outlined below:

- New claims are registered by the Employers with the Compensation Fund and the employer, if registered as a user on the online processing system is able to view claim details like the claim number allocated, and the progress of the claim online.
 - a. The allocation of a claim number by the Compensation Fund, does not constitute acceptance of liability for a claim, but means that the injury on duty has been reported to and registered with the Compensation Commissioner.
 - Any enquiries related to a claim should be directed to the employer and or the nearest Labour Centre
- If liability for a claim is accepted by the Compensation Fund in terms of the COID Act, reasonable medical expenses, related to the medical condition shall be paid to medical service providers that treat injured/diseased employee's. Reasonable medical expense shall be paid in line with its approved Tariffs and Billing rules and procedures, published annually in Government Gazettes.
- 3. If a claim is repudiated in terms of the COID Act, medical expenses for services rendered will not be paid by the Compensation Fund. The employer and the employee will be informed of this decision and the injured employee will be liable for payment.
- 4. In the case sufficient information pertaining to a claim is unavailable after registration thereof, the status of the claim will be rejected until the outstanding information is submitted and liability of the claim can be determined. Depending on the outcome, the invoices from the service provider will be dealt with as set out in 2 and 3. Please note that there are claims on which a decision might never be taken due to the non-submission of outstanding information.
- The Compensation Fund will only pay reasonable medical expenses for treatment of the condition that liability has been accepted and will not pay for any other unrelated treatment.



MEDICAL SERVICE PROVIDERS REGISTRATION REQUIREMENTS WITH THE COMPENSATION FUND

The Compensation Fund requires that any Medical Service Provider who seeks to treat patients in terms of the COID Act must register their details including their banking details with the Compensation Fund. They must thereafter register as a user of the online processing system.

The steps that are to be followed are detailed hereunder:

REGISTERING WITH THE COMPENSATION FUND AS A MEDICAL SERVICE PROVIDER TREATING INJURED/DISEASED EMPLOYEES

- 1. Copies of the following documents must be submitted:
 - a. A certified identity document of the practitioner
 - b. Certified valid BHF certificate
 - c. Bank Statement not older than one month with a bank stamp.
 - d. Proof of address not older than 3 months.
 - e. Submit SARS Vat registration number document where applicable. If this is not provided the Medical Service Provider will be registered as a Non VAT vendor.
 - f. Submit proof of dispensing licence where applicable.
- A duly completed original Banking Details form (W.aC 33) that can be downloaded in PDF from
 the Department of Employment and Labour Website (<u>www.labour.gov.za</u>). Please note on
 completion this form must contain the relevant bank stamp.
- Submit the following additional information on the Medical Service Provider letterhead, Cell
 phone number, Business contact number, Postal address, Email address. The Fund must be
 notified in writing of any changes in order to effect necessary changes on the systems.
- 4. The name of the switching house that submit invoices on behalf of the medical service provider.
- 5. These documents must be handed in to the nearest Labour centre for capturing.

Kindly take note of the following: All medical service providers will be subjected to the Compensation Fund vetting processes.

REGISTERING WITH THE COMPENSATION FUND AS AN ONLINE SYSTEM USER FOR MEDICAL SERVICE PROVIDER

To become an online user of the claims processing system Medical Service Providers must follow the following steps.

 Register as an online user with the Department of Employment and Labour on its website (www.labour.gov.za)



- 2. Register on the CompEasy application
 - a. The following documents must be at hand to upload
 - i. A certified copy of identity document (not older than a month from the date of application)
 - ii. Certified valid BHF certificate
 - iii. Proof of address not older than 3 months
 - b. In the case where a medical service provider wishes to appoint a proxy to interact on the claims processing system the following ADDITIONAL documents must be uploaded
 - i. An appointment letter for proxy (the template is available online)
 - ii. The proxy's certified identity document (not older than a month from the date of application)
- 3. There is an online instructions to guide a user on registering as an online user (www.compeasy.gov.za)



BILLING PROCEDURE TO BE ADHERED TO WHEN BILLING FOR MEDICAL SERVICES PROVIDED TO INJURED/DISEASED EMPLOYEES

- 1. All service providers should be registered on the Compensation Fund claims processing system in order to capture medical invoices and reports for medical services rendered.
- Prior to submitting, uploading or switching medical invoices and supporting reports, medical service providers should ensure that the claim is one that the Compensation Fund has accepted liability for and therefore reasonable medical expenses can be paid.
- 3. Medical Reports:
 - a. The first medical report (W. CL 4), completed after the first consultation must confirm the <u>clinical</u> description of the injury/disease. It must also detail any procedure performed and also any referrals to other medical service providers where applicable.
 - b. All follow up consultations must be completed on a Progress Medical Report (W.CL5). It must also detail any operation/procedure performed and also any referrals to other medical service providers where applicable.
 - A progress medical report is considered to cover a period of 30 days, with the exception where a procedure was performed during that period then an additional operation report will be required.
 - ii. Only one medical report is required when multiple procedures are done on the same service date.
 - c. When the injury/disease being treated stabilises a Final Medical Report must be completed (W.CL 5F).
 - d. Medical Service Providers are required to keep copies of medical reports which should be made available to the Compensation Commissioner on request.

4. Medical Invoices

- a. The Compensation Fund allows the submission of invoices in 3 different formats, the use of a switching house, directly uploading the invoice onto the processing application and the receipt of manual invoices by Labour Centre's. The former two are encouraged for Medical Service Providers to use, whilst the last form is for Medical Service Providers who have a small amount of invoices to submit.
- b. Medical invoices should be switched to the Compensation Fund using the attached format or electronic invoicing file layout. It must be noted that the corresponding medical report must be uploaded online prior to the invoice data being switched, to avoid systematic rejections on receipt.
- c. The processing system has an online guide available to guide Medical Service Providers for the direct uploading of invoice on the application.
- d. The status of invoices /claims can be viewed on the Compensation Fund claims system. If invoices are still partially or wholly outstanding with no reason indicated, after 60 days following submission, the service provider should complete an enquiry form, W.Cl 20, and submit it ONCE to the Provincial office/Labour Centre. All relevant details regarding Labour Centres are available on the website (www.labour.gov.za)



- e. Manual invoices and their corresponding medical reports must be handed in to the nearest labour centre.
- 5. The progress status of successfully submitted invoices can be viewed on the Compensation Fund online portal/APP.
- 6. If a medical service provider claims an amount less than the published tariff amount for a code, the Compensation Fund will only pay the claimed amount.
- 7. If a medical service provider claims an amount more than the published tariff amount for a code, the Compensation Fund will only pay the Gazetted amount.

MINIMUM OF INFORMATION TO BE INCLUDED ON MEDICAL INVOICES SUBMITTED TO THE COMPENSATION FUND:

The following must be indicated on a medical invoice in order to be processed by the Compensation Fund

- 1. The allocated Compensation Fund claim number
- 2. Name and ID number of employee
- 3. Name and Compensation Fund registration number, as indicated on the corresponding Employers Report of Accident (W.CL 2), for switched invoices
- 4. DATES:
 - a. Date of accident
 - b. Date of service (From and To)
- 5. Medical Service Provider BHF practice number
- 6. VAT registration number (VAT will not be paid if a VAT registration number is not supplied on the invoice)
- 7. Tariff Codes:
 - a. Tariff code applicable to injury/disease as in the official published tariff guides
 - b. Amount claimed per code and the total of the invoice
- 8. VAT:
 - a. The tariff amounts published in the tariff guides to medical services rendered in terms of the COID Act of 1993 do not include VAT. All invoices for services rendered will be assessed without VAT. Only if it is indicated that the service provider is registered as a VAT vendor and a VAT registration number is provided, will VAT be calculated and added to the payment, without being rounded off.
 - b. The only exception is the "per diem" tariffs for Private Hospitals that already include VAT.
 - c. Please note that there are VAT exempted codes in the Private Ambulance tariff structure.
- 9. All pharmacy or medication invoices must be accompanied by the original scripts
- 10. Where applicable the referral letter from the treating practitioner must accompany the medical service providers' invoice.
- 11. All medical invoices must be submitted with invoice numbers to prevent system rejections. Duplicate invoices should not be submitted.

PLEASE NOTE: The Compensation Fund will withhold payments it medical invoices do not comply with minimum submission and billing requirements as published in the Government Gazette



REQUIREMENTS FOR SWITCHING MEDICAL INVOICES WITH THE COMPENSATION FUND

The switching provider / third party must comply with the following requirements:

- 1. Register with the Compensation Fund as an employer.
- 2. Host a secure FTP (or SFTP) server to ensure encrypted connectivity with the Fund. This requires that they ensure the following:
 - a. Disable Standard FTP because is now obsolete. ...and use latest version and reinforce
 FTPS protocols and TLS protocols
 - b. Use Strong Encryption and Hashing.
 - c. Place Behind a Gateway.
 - d. Implement IP Blacklists and Whitelists.
 - e. Harden Your FTPS Server.
 - f. Utilize Good Account Management.
 - g. Use Strong Passwords.
 - h. Implement File and Folder Security
 - i. Secure your administrator, and require staff to use multifactor authentication
- 3. Submit and complete successful test file after registration before switching the invoices.
- 4. Validate medical service provider's registration with the Board of Healthcare Funders of South Africa.
- 5. Submit medical invoices with gazetted COIDA tariffs that are published annually.
- 6. Comply with medical billing requirements of the Compensation Fund.
- 7. Single batch submitted must have a maximum of 100 medical invoices.
- 8. Eliminate duplicate invoices before switching to the Fund.
- 9. File name must include a sequential batch number in the file naming convention.
- 10. File names to include sequential number to determine order of processing.
- 11. Medical Service Providers will be subjected to Compensation Fund vetting processes.
- 12. Third parties must submit a power of attorney.
- 13. Submit any information/documentation requested by the Fund.
- 14. Only pharmacies should claim from the NAPPI file.

Failure to comply with the above requirements will result in deregistration / penalty imposed on the switching house.

ORTHOTIC & PROSTHETIC SUPPLY PROTOCOL

COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASES ACT, 1993

Section 73 Medical expenses (1) The Director-General or the employer individually liable or mutual association concerned, as the case may be, shall for a period of not more than two years from the date of an accident or the commencement of a disease referred to in section 65(1) pay the reasonable cost incurred by or on behalf of an employee in respect of medical aid necessitated by such accident or disease.

(2) If, in the opinion of the Director-General, further medical aid in addition to that referred to in subsection (1) will reduce the disablement from which the employee is suffering, he may pay the cost incurred in respect of such further aid or direct the employer individually liable or the mutual association concerned, as the case may be, to pay it.

Section 42 Employee to submit to medical examination (1) An employee who claims compensation or to whom compensation has been paid or is payable shall when so required by the Director-General or the employer individually liable or mutual association concerned, as the case may be, after reasonable notice, submit himself at the time and place mentioned in the notice to an examination by the medical practitioner designated by the Director-general or the employer individually liable or mutual association concerned.

- 1.1 Each Medical Service Provider should ensure that the service they provide is compatible with the general procurement guidelines issued by National Treasury.
- 1.2 The Compensation Fund will bear the reasonable cost for the issue of Orthotic and Prosthetic devices after an accident, provided that liability for the claim has been accepted and the service is prescribed by a medical practitioner and the prescribed guidelines are followed.
- 1.3 The published policy on the Supply of Orthotic and Prosthetic devices and the tariff of fees will serve as a guideline to determine if any proposed service is reasonable and it will replace all existing tariff structures.
- 1.4 Pre-authorization by the Compensation Fund is required in all claims, even if the devices supplied are listed in the Government Gazette. It is the responsibility of the Medical Service Provider to ensure that liability for the claim has been accepted by the Compensation Fund and that the service is reasonable and in line with the published policy and tariff. Amputees must be fitted with a prosthesis which is suitable for their environment and activity / load level.

- 1.5 Replacement of consumable items, refits and repairs must be motivated by the Medical Service Provider. All requests must be accompanied by photos of the Orthotic / Prosthetic Device to be replaced or repaired. Requests must be reasonable and in line with the published policy and tariff.
- 1.6 The employee, assisted by the Medical Service Provider should complete the appropriate form when requesting replacement, re-fit or repair of any Prosthetic / Orthotic device. Refer to Form 6 Orthotic / Prosthetic Services Request Form
- 1.7 The request for new equipment must be accompanied by a written report by the Medical Service Provider indicating that the employee's functional level has been re-evaluated to take into account any physical or environmental changes encountered by the employee. Refer to AMPPRO Test for Lower limb amputees
- 1.8 In exceptional circumstances, if the employment status and / or the functional level of an employee radically changes before a new prosthesis is due, a new prosthesis more suitable to the employment conditions will be considered by the Compensation Fund.
- 1.9 If an employee's employment status / functional level changes and a prosthesis in a higher category is requested, such higher functional level must be confirmed by the Employer and a rehabilitation team comprising of a Medical Doctor, the Prosthetist, a Physiotherapist and / or an Occupational Therapist.
- 1.10 The Medical Service Provider must obtain written authorisation for all quotations of Orthotic or Prosthetic devices, refits, consumables and repairs. Accounts will not be payable for any Orthotic or Prosthetic device supplied to the employee without pre-authorisation.
- 1.11 The Compensation Fund will bear the reasonable cost of repairs to a prosthesis which has suffered from "fair" wear and tear after at least two years of normal use.
- 1.12 The Compensation Fund will not bear the cost of a prosthesis which is lost, broken, worn out or is otherwise unserviceable as a consequence of an employee's neglect or abuse.
- 1.13 The Commissioner will pay for the re-fit of the prosthesis strictly only where motivated and justifiable by the circumstances. Refer to Section 4 Guidelines for Refit
- 1.14 Replacement of consumables of Orthotic or Prosthetic devices that may perish or become consumed through reasonable usage will be paid for by the Compensation Fund in line with the policy guidelines. Refer to Section 3 Replacement Period Table.
- 1.15 The Compensation Fund reserves the right in terms of section 42 of the Act to call for a second or independent opinion or evaluation of proposed Orthotic/Prosthetic services.
- 1.16 Any such report obtained by the Compensation Fund shall state whether the proposed Orthotic/Prosthetic service is appropriate for the diagnosis, functional level and environmental circumstances of the patient. The Compensation Fund reserves the right to use the information so obtained at its discretion and as is deemed appropriate.

- 1.17 The Commissioner is further entitled, pursuant to a complaint by the employee, to call for an independent report concerning any Orthotic/Prosthetic services that have been rendered. The Medical Service Provider should strive to take all reasonable steps to attend to the legitimate complaints of an employee regarding services or assistive devices supplied. If it is found that defective or unsuitable devices have been supplied to an employee the Medical Service Provider shall replace / repair / alter such devices at no additional cost to the Compensation Fund or the employee. The Compensation Fund reserves the right to decide on whether to maintain the said service provider on their data base of service providers or not.
- 1.18 The Orthotic and / or Prosthetic devices paid for by the Compensation Fund remains the property of the Compensation Fund. When an employee demises such devices should be returned to the Compensation Fund.
- 1.19 Each request for Pre-authorization should be accompanied by a quotation on the Medical Service Provider's practice letterhead.
- 1.20 Every Medical Service Provider should supply the Compensation Fund with the rehabilitation report for all amputees after fitting and supplying of a new prosthesis.
- 1.21 Medical Service Providers are required to quote a similar or better component using the same code.
- 1.22 The Compensation Fund retains the right to verify all products supplied to the employee.
- 1.23 Acknowledgement of receipt of Orthotic/Prosthetic device should be signed by the Medical Service Provider, Injured Employee and Compensation Fund official (Form 8)
- 1.24 In order for the Compensation Fund to verify that the correct items were supplied, proof of purchase should accompany the acknowledgement of receipt for any single component/item in excess of R50 000.
- 2. Request for Orthotic / Prosthetic Services

The following details must accompany the request for prosthetic services:

- 2.1 Orthotic / Prosthetic Service Request Form (Form 6)
- 2.2 Motivation for services by Medical Service Provider
- 2.3 Doctor's Referral letter for any Primary Orthotic / Prosthetic device user
- 2.4 AMPPRO test (for Lower Limb Prosthesis only)
- 2.5 Refit report (for refit of prosthesis only)
- 2.6 Quotation according to published tariffs (Form 7)
- 2.7 Photos of Orthotic / Prosthetic device to be replaced / repaired

4. Guidelines for Refit

This guideline covers Prosthetic devices that require refit of the socket after the initial issue. A full motivation with a report indicating the following details must be submitted:

- 4.1 Date of amputation
- 4.2 Date when the current prosthesis was fitted
- 4.3 Description of the prosthesis
- 4.4 Residual limb measurements when prosthesis was fitted
- 4.5 Symptoms indicating loss of fit
- 4.6 Diagnosis of loss of fit

- 4.7 Current residual limb measurements.
- 4.8 Number and thickness of prosthetic socks worn by employee
- 4.9 Condition of prosthesis
- 4.10 The employee's current activity level
- 4.11 An opinion as to the suitability of the employee's current prosthesis
- 4.12 Photos of the prosthetic device to be refit / repaired

Functional Level

A determination of the medical necessity for certain components / additions to a prosthesis is based on the potential functional ability of the employee. Potential functional ability is defined as the reasonable expectation of the rehabilitation team including a Medical Doctor, the Prosthetist, a Physiotherapist and / or an Occupational therapist and the employee based on

- past history including prosthetic use
- current condition including the status of the residual limb and other medical factors
- employment status
- · desire to ambulate

The clinical assessment for Lower Limb amputees should be based on the AMPPRO test results.





Definition

Feet

SACH	The external keel of a foot prosthesis is the firm part on the bottom of the prosthesis, extending from the heel to the toe. The keel is both a structural support and a shock absorber as the patient transfers weight from heel to toe while walking. The SACH foot has a rubber heel wedge that lets the ankle move by compressing under weight bearing during the start of stance walking phase. It is available in different heel heights allowing wearing with various types of shoes.
SACH composite	Flexible keel prosthetic feet are more advanced than solid ankle cushioned heel or SACH feet. However, they do not return energy in the way a dynamic response foot would. It offers cushioning and absorption of energy but does not store and return the same amount of energy.
Single axis	An articulated single axis foot and ankle prosthesis uses a hinge to allow the ankle to dorsiflex and plantar flex, or move up and down. Single axis feet do this with a hinge in the prosthesis at about the location of the transverse tarsal joint on the human foot. Because the prosthesis moves in a single axis, specifically up and down, movement is in the sagittal plane only. Single axis feet differ from solid ankle cushion heel foot, or SACH, feet in several ways.

Multi axis	A multiaxial foot can move in multiple planes of direction, providing its user the ability to walk on uneven surfaces. This differs from a single axis foot prosthesis that allows only plantar flexion and dorsiflexion in the sagittal plane. This design allows the forefoot of the foot or ankle mechanism to move appropriately on uneven surfaces, much as a human foot would.
ESAR	The foot uses a carbon and/or nylon flexible internal keel, a firm yet flexible plate located inside the sole of the prosthesis, extending from the heel to the toe. The keel is both a structural support and a shock absorber as the patient transfers weight from heel to toe while walking. The dual spring action of the keel gives a smooth transition from heel to toe as the foot moves through a walking gait, giving additional stability and confidence to its wearer.
Active suspension	Elevated vacuum suspension which controls and reduces volume fluctuations during ambulation. The suspension is a mechanism which incorporates the foot and socket suction suspension to achieve the desired elevated vacuum.
Axial rotation	An axial rotation unit allows a prosthetic limb to twist to the right or the left, helping people walk more naturally. The axial rotation accommodate rotational forces during heel strike, mid stance, terminal stance and pre-swing. Properly functioning axial rotation devices allow a socket to relieve pressure on the stump as the patient moves.
Low profile	Decreased build height which accommodates longer residual limbs with limited ground clearance
ESAR - multi axial	A multiaxial foot primarily manufactured out of carbon fiber which can move in multiple planes of direction, providing its user the ability to walk on uneven surfaces. This design allows the forefoot of the foot or ankle mechanism to move appropriately on uneven surfaces, much as a human foot would.
Carbon pylon	One end of the pylon directly fits into the residual limb socket, and the other end fits into the prosthetic foot. The aim of the prosthetic pylon is to store and release energy additional energy to the
Heel adjustable	This code describes prosthetic foot with a heel height that the patient can adjust to the desired angle. Not only does this benefit a patient cosmetically by allowing adjustment to the prosthetic heel to the shoe heel height, but it can also help foot balance and support the knee, improving the patient's gait.
ESAR multi composite	The foot uses nylon, glass fibre or other composites with flexible internal keel, a firm yet flexible plate located inside the sole of the prosthesis, extending from the heel to the toe. The keel is both a structural support and a shock absorber as the patient transfers weight from heel to toe while walking. The dual spring action of the keel gives a smooth transition from heel to toe as the foot moves through a walking gait, giving additional stability and confidence to its wearer.
