GENERAL NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of Section 11A (4) of the Restitution of Land Rights Act, Act No. 22 of 1994 as amended that an amendment is hereby made to the Gazette Notice 356 of 2006, Government Gazette No. 28575 dated 03rd March 2006. The amendment of this gazette is made to withdraw the farms Government Ground 503 KS and Ironstone 847 KS and to include the farm Geluk oos 513 KS, these farms are situated within Sekhukhune District: Limpopo

The land claim was lodged before the cut-off date of 31st December 1998. The date falls within the prescribed period for lodgment of land claims as laid down in Section 2(1) (e) of Restitution of Land Rights Act, 1994 (Act No.22 of 1994) as amended.
