Notice is hereby given in terms of Section 11 A (3) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994) as amended, that a claim for the restitution of land rights lodged on the 9 September 1998 by Tilongo John Zimu in the District of Umgungundlovu, KwaZulu-Natal which was published in the Government Gazette No. 29352 dated 10 November 2006, Notice No. 1560 of 2006 under reference number KRNE/22/E/38/0/0/54, that the properties described in the schedule attached to this notice are no longer subject to the land claim published in the aforesaid notice and are hereby **WITHDRAWN** by the Regional Land Claims Commissioner
