# DEVELOPMENT OF THE B-BBEE SECTOR CODE FOR THE EVENTS, TECHNICAL AND PRODUCTION SERVICES INDUSTRY.

The Events, Technical and Production Services Transformation Forum (ETPTF) wishes to update stakeholders that, the consultations for the development of the B-BBEE Sector Code for the Events, Technical and Production Services Industries (ETPTSI) are now at a final stage. The ETPTF is supported by the Department of Sport, Arts and Culture (DSAC) as a line function. The consultations were initiated in the year 2021/22, through a series of Webinars, followed by 3 Cluster Provincial physical consultations in 2022/23 and (9) Province to Provinces consultations in 2023/24. A draft B-BBEE Sector Code has been developed with significant recommendations including a special focus on the 5 elements of the score card listed below:

- 1. Ownership
- 2. Management Control
- 3. Skills Development and Broad-based Black Economic Empowerment
- 4. Enterprise Development and Broad-based Black Economic Empowerment
- 5. Socio Economic Development and Broad-based Black Economic Empowerment.

The draft B-BBEE Sector Code is available on the website of the Department of Sport, Arts and Culture (<a href="www.dsac.gov.za">www.dsac.gov.za</a>) on the homepage under announcements.

All interested and affected companies, organisations and individuals are invited to participate in the process by reading through the draft and submit written Recommendations and Comments on the overall draft Sector Code including attention to the Weightings and Targets of each score card proposed by the ETPF. The closing date for submissions has been extended for stakeholders to submit on or before the **30 April 2024**. After the 30<sup>th</sup>April the ETPTF will consider the recommendations and comments received and update the draft for the commencement of the Gazetting stage.
