NOTICE TO COMPLY WITH THE USE OF OFFICIAL LANGUAGES ACT, Pan SOUTH AFRICAN LANGUAGE BOARD ACT AND THE CONSTITUTION

NOTICE

It is in accordance with section 8(1)(b) of the PanSALB Act that PanSALB requests national departments and their public entities and public enterprises to supply it individually so, with any legislative, executive and/or administrative measures adopted in promoting multilingualism through language policy practices (use).

A notice is hereby given in terms of section 9(2) of the Use of Official Languages Act (UOLA), No. 12 of 2012 for the national departments, national public entities and national public enterprises to submit an annual language report on:

- (1) activities of their language unit,
- (2) implementation of their language policy, and
- (3) complaints received and the manner those complaints were handled.

The submission of these annual language reports is regulated in terms of the UOLA Regulation 5(1) that national organs of state must submit them at least three (3) months after the end of the financial year meaning **not later than 30 June 2024.**

RECOMMENDATION

PanSALB hereby recommends to all national departments, national public entities and national public enterprises to supply it with information on the administrative measures they have adopted to implement the Constitution Eighteenth Amendment Act 3 of 2023 which recognizes South African Sign Language as one of the official languages of the Republic.

The PanSALB Act provides that all organs of state shall afford PanSALB such assistance as may reasonably be required for the protection of the PanSALB independence, impartiality, dignity, and effectiveness in the exercise, carrying out, and performance of the Board's powers, duties, and functions.

The 2023-24 Annual Language Report on the Use of Official Languages and information in terms of the recommendation above must be submitted to PanSALB **not later than 30 June 2024** through the following means:
