#### **NOTIFICATION: PRODUCTION RIGHT EXTENSION ENVIRONMENTAL AUTHORISATION APPLICATION PROCESS.**

Tetra4 (Pty) Ltd (hereafter referred to as the applicant) has appointed Environmental Impact Management Services (Pty) Ltd (EIMS) as the Environmental Assessment Practitioner (EAP) to assist with undertaking the required authorisation processes (including the statutory public participation) and to compile and submit the required documentation.

- Environmental Authorisation (EA) and amendments in accordance with the National Environmental Management Act- NEMA (Act 107 of 1998).
  - Amendment of Rights, Permits, Programmes, and/or Plans in accordance with Section 102 of the Mineral and Petroleum Resources Development Act – MPRDA (Act 28 Of 2002).

Additional listed activities and/or water uses may be identified during the process.

**Activity:** Tetra4 is the operator and holder of existing Exploration Rights and a Production Right, in the Matjhabeng and Masilonyana Local Municipalities, in terms of the Mineral and Petroleum Resources Development Act (No. 28 of 2002 - MPRDA). The Production Right covers an area of 187 000 ha and the 2 Exploration Rights cover a combined area of 18 733.1 ha. Tetra4 intends to consolidate the Exploration Rights (including activities such as drilling of up to 18 wells) within the Production Right area.

**Location:** This consolidation will incorporate ~81 farm portions near the towns of Theunissen and Winburg in the south and Odendaalsrus and Allanridge in the north (comprising the Exploration Rights) into the Production Right. The Exploration Right (ER32) located north of the Production Right is approximately 7.2 km Northwest of Welkom and the Exploration Right (ER94) to the south of the Production Right is approximately 19.2 km South of Virginia

EIMS will be following the procedures defined in the EIA Regulations for undertaking a Basic Assessment process. In accordance with Chapter 6 of the EIA Regulations, a public participation process will be undertaken. You are hereby invited to register and comment on the proposed project and application/s. Please note that only registered interested and affected parties (I&AP's) will be informed of future project information and opportunities for participation. #### KENNISGEWING: PRODUKSIE REG UITBREIDING OMGEWINGSMAGTIGING AANSOEKPROSES.

Tetra4 (Pty) Ltd (hierna na verwys as die aansoeker) het Environmental Impact Management Services (Edms) Bpk (EIMS) as die Omgewingsevalueringsspraktisy (EAP) aangestel om die nodige magtigingsprosesse (insluitend die statutêre openbare deelname), en om die vereiste dokumentasie saam te stel en in te dien.

**Aktiwiteit:** Tetra4 is die operateur en houer van bestaande Eksplorasieregte en 'n Produksiereg, in die Matjhabeng en Masilonyana Plaaslike Munisipaliteite, in terme van die Wet op die Ontwikkeling van Minerale en Petroleumhulpbronne (Wet 28 van 2002 - MPRDA). Die Produksiereg dek 'n area van 187 000 ha en die 2 Explorasieregte dek 'n gesamentlike area van 18 733.1 ha. Tetra4 mik om die Eksplorasieregte te konsolideer binne die Produksiereg area (insluitend aktiwiteite soos boor van, tot en met, 18 boorgate).

**Ligging:** Hierdie konsolidasi sal ~81 plaasgedeeltes naby die dorpe Theunissen en Winburg in die suide en Odendaalsrus en Allanridge in die noorde (wat die Eksplorasieregte behels) by die Produksiereg insluit. Die Eksplorasiereg (ER32), noord geleë vanaf die Produksiereg, is ongeveer 7.2 km Noordwes vanaf Welkom en die Eksplorasiereg (ER94), suid geleë vanaf die Produksiereg, is ongeveer 19.3 km Suid vanaf Virginia.
