By virtue of the functions, powers and/or duties vested in me, in my capacity as a Deputy Governor of the South African Reserve Bank, in terms of the delegation and assignment of the functions, powers and/or duties referred to in paragraph 1 above, I hereby give notice of a decision to forfeit to the State the following money and I hereby declare and order forfeit to the State the following money, namely:
  - 2.1 The amount of EUR40 341 231.27 (as at 2024-06-14), standing to the credit of the Respondent in account number 090790502, held with The Standard Bank of South Africa Limited together with any interest thereon or any other accrual thereto.
  - 2.2 The amount of R311 312 385.10 (as at 2024-06-14), standing to the credit of the Respondent in account number ASHUT92654 (Ashburton Investment account with Investor ID 661030), held with FirstRand Bank Limited together with any interest thereon or any other accrual thereto.

- 2.3 The amount of R223 279 565.17 (as at 2024-06-14), standing to the credit of the Respondent in account number 63057698624, held with FirstRand Bank Limited together with any interest thereon or any other accrual thereto.
- 3. The date upon which the money specified in paragraph 2 above is hereby forfeited to the State is the date upon which this Notice and Order of Forfeiture is published in this *Gazette*.
- 4. The money specified in paragraph 2 above shall be disposed of by deposit thereof into the National Revenue Fund.
