INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA**NOTICE 2721 OF 2024****ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)****NOTICE OF PUBLIC HEARINGS TO BE HELD IN RESPECT OF THE APPLICATIONS FOR APPROVAL FOR THE TRANSFER OF CONTROL OF THE INDIVIDUAL ELECTRONIC COMMUNICATIONS NETWORK SERVICE ("I-ECNS"), INDIVIDUAL ELECTRONIC COMMUNICATIONS ("I-ECS") AND RADIO FREQUENCY SPECTRUM ("RFS") LICENCES FROM CELL C LIMITED ("CELL C") TO THE PREPAID COMPANY (PTY) LTD ("TPC")**

1. The Independent Communications Authority of South Africa ("ICASA / the Authority") hereby gives notice of public hearings to be held in relation to the Applications for the transfer of control of the I-ECNS and I-ECS licences from Cell C to TPC.
2. On 26 September 2023, Cell C submitted the following applications to the Authority:
 - 2.1 an application for the transfer of control of its I-ECNS and I-ECS licences to TPC in terms of section 13(2) of the Electronic Communications Act, 36 of 2005 ("ECA"); and
 - 2.2 an application for the transfer of control of its radio frequency spectrum licences ("RFS Licences") to TPC ("the RFS Transfer Application") in terms of section 31(2A) of the ECA.
3. On 6 December 2023, the Authority published a notice of the Applications in Government Gazette No. 49831 ("the Notice"). In terms of the Notice, the Authority invited interested parties to make written representations in response to the Applications within 14 working days from the date of publication of the Notice.

4. Subsequent to the Notice, the Authority extended the deadline for submission of written representations and responses to 22 January 2024 and 12 February 2024, respectively.
5. By the closing date of 22 January 2024, the Authority received 6 written representations from stakeholders who also expressed an interest to make oral submissions.
6. On 31 January 2024, the Authority extended the deadline for the submission of Cell C's written response to 15 March 2024.
7. On 15 March 2024, Cell C submitted its written responses to the various representations received by various stakeholders.
8. The Authority will hold the public hearings on **Thursday, 19 September 2024**.
9. Please be advised that Cell C has withdrawn its application for transfer of the 10 MHz Lot in the 3500 MHz RFS band that they bid for during the 2022 Spectrum Auction. Therefore, the hearings will not address this issue.
10. The Authority hereby invites all stakeholders and interested persons to the public hearings in relation to the above-mentioned applications. The public hearings will be held as follows:
