NOTICE IN TERMS OF REGULATION 2(4) OF THE NORTH WEST LAND TRANSPORT REGULATIONS, 2021, MADE IN TERMS OF SECTION 10 OF THE NATIONAL LAND TRANSPORT ACT, 2009 (ACT NO. 5 OF 2009): INVITATION FOR PUBLIC COMMENTS

1.
