CALL FOR NOMINATIONS OF PERSONS TO SERVE ON THE BOARD OF THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD (CIDB)

The Construction Industry Development Board (CIDB) is a Schedule 3A Government entity that reports to the Minister of Public Works and Infrastructure. It operates in terms of the Construction Industry Development Board Act, 2000 (Act No. 38 of 2000). The CIDB plays a significant role in promoting a regulatory and developmental framework that builds the state's construction delivery capability for social and economic benefits. The core mandate of the entity is to facilitate and promote the contribution of the construction industry to South Africa's economy and society.

Members of the Board of the CIDB are the Accounting Authority of the public entity in terms of the Public Finance Management Act (Act No. 1 of 1999) and their

The Board members will serve for a period of three (3) years from the date of appointment by the Minister. In line with the Act, the Minister is required to re-appoint one third of the board members that are currently serving. All board members that are eligible for re-appointment should apply through the nomination procedure outlined hereto.

The nominated persons shall be competent persons with experience and/or expertise in the construction industry, built environment and infrastructure development, infrastructure financing, construction health and safety, human capital development, corporate governance, management science, financial management, law, communications, marketing, international standards related to infrastructure and information communication technology.

The nominated persons are also expected to have knowledge of the needs and functions of various sectors within the industry. This includes organs of state regulating the construction industry; regulatory bodies in the built environment, scientific and professional institutions; construction industry voluntary associations; suppliers of building materials for infrastructure development and knowledge of the functions of the construction liaison office and other related community engagement structures.

Shortlisted nominees will be subjected to a screening process and any other compliance requirement, which will determine eligibility to continue as a Board member.
