

THE NATIONAL DEVELOPMENT OF LEARNERSHIPS, EMPLOYMENT SKILLS
AND LABOUR ASSESSMENTS (INDLELA)**

I, Dr Nobuhle Pamela Nkabane, MP, Minister of Higher Education and Training, hereby publish the following schedule attached hereto for costs of services rendered by INDLELA as a public Trade Test Centre accredited by the Quality Council for Trades and Occupations and furthermore repeal Government Notice No 437 published in Government Gazette No 42323 dated 22 March 2019, related to fees for services rendered by INDLELA.

SCHEDULE 1

With effect from 1 April 2025 the following costs will apply to services rendered by INDLELA situated in Olifantsfontein as a Quality Council for Trades and Occupations (QCTO) accredited public Trade Test Centre.

1. Trade test fees for all trade tests conducted at INDLELA for which the institution is accredited will be R600.00 per full trade test, as well as for a trade test where recognition for tasks were granted in previous trade test attempts and are still valid and applicable in terms of the Trade Test Regulations.
2. Costs for Artisan Recognition of Prior Learning (ARPL) services rendered at INDLELA within the institution's scope of accreditation will be as follows:
 - 2.1. The provisioning of administration and evaluation services R300.00 per applicant.
3. Costs related to any training programs provided by INDLELA will be as follows:
 - 3.1. The provisioning of top up training to a maximum of 20 days as well as Assessment Practitioner Training programs at R150.00 per person per day.
4. Costs related to hostel accommodation for clients utilizing INDLELA services requiring accommodation for the service duration will be as follows:
 - 4.1. Accommodation for ARPL candidates, Trade Test candidates, top up training and Assessment practitioner learners will be provided for the duration of the specific activity on request from the applicant at an additional cost of R250 per person per day which will include bed and breakfast during weekdays.
 - 4.2. For longer term accommodation where the services require such extending over weekends or public holidays the accommodation rate would be R 200 per person per day "bed only" and no breakfast would be provided.
5. An annual standardised increase in fees for the services provided by INDLELA as listed above of 5 % (five percent) will apply as from 1 April 2026 moving forward, implemented at the commencement of each financial year.
6. Applications for the re-issue of lost or damaged trade certificates will be charged according to the circular issued on an annual basis by the Quality Council for Trades and Occupations (QCTO).
