


**DEPARTMENT OF HEALTH****NO. 5633****6 December 2024****HEALTH PROFESSIONS ACT, 1974 (ACT NO.56 OF 1974)****REGULATIONS RELATING TO THE CONSTITUTION OF THE PROFESSIONAL  
BOARD FOR ENVIRONMENTAL HEALTH PRACTITIONERS**

The Minister of Health has, under section 15(4) of the Health Professions Act, 1974 (Act No. 56 of 1974), and on the recommendations of the Health Professions Council of South Africa, made the regulations in the Schedule.

## SCHEDULE

### Definitions

1. In these Regulations any expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context indicates otherwise -

**“board”** means the Professional Board for Environmental Health Practitioners established in terms of section 15 of the Act;

**“designated groups”** means black people, women and persons with disabilities; and

**“the Act”** means the Health Professions Act, 1974 (Act No. 56 of 1974).

### Constitution of the board

2. (1) The board consists of nine members appointed by the Minister and who permanently reside in South Africa:

(a) seven environmental health practitioners, of whom at least five must be from designated groups appointed on the basis of nominations by persons whose names appear in the register of environmental health practitioners;

(b) one person representing the department of health; and

(c) one community representative.

- (2) Designated groups must be protected and advanced in the following order of the levels of disadvantage of the past, which must be taken into consideration in the appointment process:

(a) women

(b) men of African, Asian or Coloured descent; and

(c) disabled persons, irrespective of descent.

**Repeal of laws**

3. The Regulations relating to the Constitution of the Professional Board for Environmental Health Officers published under Government Notice No. R. 1253 in Government Gazette No. 31633 of 28 November 2008 are hereby repealed.

**Short title**

4. These Regulations are called Regulations Relating to the Constitution of the Professional Board for Environmental Health Practitioners, 2024.

1. Kha idzi Ndangulo kuambele kuňwe na kuňwe kune kwa amba zwine zwa vha kha Mulayo na hanefha ku amba zwenezwo zwi re kha Mulayo, nga nn̄da ha musi nyimele i tshi khou sumbedza nga iňwe nđila -

“**bodo**” zwi amba Bodo ya Phurofeshina ja ya Vhoramutakalo vha zwa Mupo yo thomiwaho u ya nga khethekanyo ya 15 ya Mulayo;

“**zwigwada zwo topolwaho**” zwi amba vharema, vhabumakadzi na vhathu vha re na vhuholefhali; na

“**Mulayo**” zwi amba Mulayo wa Phurofesheni dza Mutakalo wa, 1974 (Mulayo wa Nomboro ya. 56 wa 1974).

**Kuvhumbelwe kwa bodo**

2. (1) Bodo i na mirađo ya ţahe yo tholiwaho nga Minis̄ta nahone mirađo iyi i dzula Afrika Tshipembe lwa tshothe:

(a) vhoramutakalo vha zwa mupo vha sumbe, vhane vha sa vhe fhasi ha vhaṭanu vha bva kha zwigwada zwo topolwaho vhane vho tholwa ho sedzwa u ḥangiwa nga vhathu vhane madzina avho a vha hone kha redzhis̄tara ya vhoramutakalo vha zwa mupo;

(b) muthu muthihi u imela muhasho wa mutakalo; na

(c) mulimeli muthihi wa tshitshavha.

(2) Zwigwada zwo topołwaho zwi fanelu u tsireledzwa na u khwiñefhadzwa nga ndila i tevhelaho kha maimo a tshiçalula tsha tshifhinga tsho fhelaho, zwiné izwi zwa fanelu u dzhielwa nzhele kha kuitele kwa u thola:

- (a) vhafumakadzi;
- (b) vhanna vha Vharema, vhanna vha Asia na vhanna vhane tsinde Javho ji bva kha makhaładi; na
- (c) vhathu vha re na vhuholeħall, hu songo sedzwa tsinde ja vhubvo.
