MARINE LIVING RESOURCES ACT, 1998 (ACT NO. 18 OF 1998)

AMENDMENT OF THE REGULATIONS PUBLISHED IN TERMS OF THE MARINE LIVING RESOURCES ACT, 1998 (ACT NO. 18 OF 1998) IN GOVERNMENT NOTICE NO. R. 1111, GOVERNMENT GAZETTE NO. 19205 OF 2 SEPTEMBER 1998: WEST COAST ROCK LOBSTER FISHING SEASON

I, Dion Travers George, Minister of Forestry, Fisheries and the Environment hereby, in terms of section 77(1) and 77(2)(*I*) of the Marine Living Resources Act, 1998 (Act No. 18 of 1998), amend the Regulations in terms of the Marine Living Resources Act, 1998, as set out in the Schedule hereto.

These amendments to the Regulations in terms of the Marine Living Resources Act, 1998, amend the season for the recreational fishing of West Coast Rock Lobster.

SCHEDULE

Definitions

1. Amendment of regulation 51 of the Regulations

- **2.** Regulation 51 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:
 - "(2) A person over the age of 12 years may obtain from any authorised office, a recreational fishing permit, subject to the payment of the fees determined by the Minister under section 25 of the Act, to engage in fishing, collecting, keeping, controlling, landing or transporting of, or to be in possession of not more than four west coast rock lobster per day on 16, 29, 30 and 31 December 2024, on 1, 4, 5 and 12 January 2025; and on 21, 22, 29 and 30 March 2025. Fishing is allowed every day on the dates specified in this subregulation. No fishing is permitted on any day not listed in this sub regulation."

Amendment of Annexure 2 of the Regulations

- **3.** Annexure 2 to the Regulations is hereby amended by the substitution for paragraph *(b)* of item 7 of Part A of the following paragraph:
 - "(b) recreational permit from 31 March 2025 to 15 December 2025, all dates inclusive.".

Commencement

4. These regulations take effect on the date of publication in the *Gazette*.
