### APPLICATION FOR EXEMPTION OF AN INDIVIDUAL COMMERCIAL SOUND BROADCASTING SERVICE LICENSE BY KAGISO MEDIA PTY) LTD IN RELATION TO KAYA FM (PTY) LTD ("KAYA FM")

- The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from Kagiso Media (Pty) Ltd ("the Applicant"), for an exemption of the provisions of limitations of control on section 65(2) in relation to its shareholding in Kaya FM. The exemption application is lodged in terms of section 65(6) of the Electronic Communications Act, No 36 of 2005 ("EC Act").
- The exemption application seeks the approval from the Authority to grant the Applicant an exemption under section 65(6) from the operation of section 65(2) of the EC Act to address Kagiso Media's shareholding in the sound broadcasting licensees.

- 6.2. Voting rights in Kaya FM will increase from 19.731% to 34.791%, held
  - 6.2.1. as to Kagiso Media (through Shanike Investments) with economic rights of 24.900% and Voting rights of 12.201%; and
  - 6.2.2. as to KMI (through TCTH) with economic rights of 22.590% and voting rights of 22.590%.
