Dear Valued Customer**Re: APPOINTMENT OF DEBT COLLECTOR BY GOVERNMENT PRINTING WORKS**

In terms of the Public Finance Management Act (PFMA), Section 38(1) (c) (i) and Treasury Regulation 11.2.1, the Accounting Officer of an institution is required to take effective and appropriate steps to timeously collect all the money due to the institution.

Section 38(1)(f) of PFMA, read with Treasury Regulation 8.2.3, requires that all payments due to creditors must be settled within 30 days from receipt of invoice.
