MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944)

APPOINTMENT OF PLACES WITHIN EACH REGIONAL DIVISION FOR THE HOLDING OF A COURT FOR THE ADJUDICATION OF CERTAIN CIVIL DISPUTES AND MAGISTERIAL DISTRICTCS AND SUB-DISTRICTS AND AREAS IN RESPECT OF WHICH SUCH SHALL HAVE JURISDICTION

- 1. I, Mmamoloko Kubayi, Minister of Justice and Constitutional Development, acting under section 2(1) (eA), (g)(ii), (iA), (iii) and (l) of the Magistrates' Courts Act, 1944 (act No. 32 of 1944), hereby-
 - (a) establish a court for each regional division for the purpose of adjudicating civil disputes contemplated in section 29(1) and 29(1B) of the Act;
 - (b) appoint within each regional division mentioned under Column A, places listed under Column C of the Schedule for the holding of a court for the adjudication of civil disputes in section 29(1) and section 29 (1B) of the Act;
 - (c) prescribe in Column D of the Schedule hereto, the local limits within which the court sitting at the place in Column C shall have jurisdiction; and
 - (d) withdraw Government Notice No. 1161 published in Government Gazette No. 1161 dated 30 October 2020.
- 2. This Notice will come into effect upon publication.
- 3. Despite the withdrawal of Government Notice No. 1161 of 30 October 2020, proceedings which have already started but have not been concluded on the date referred to in paragraph 2 of this Notice, may be proceeded with and concluded as if this Notice has not been published.
