INVITATION TO COMMENT ON THE DRAFT MINISTERIAL DETERMINATIONS ON FEES PAID FOR CUSTOMARY INITIATION

In terms of sections 18(3)(b) and 41(4)(b) of the Customary Initiation Act, 2021 (Act No 2 of 2021), I, Mr V F Hlabisa, Minister of Cooperative Governance and Traditional Affairs, hereby publish the Draft Determinations on fees paid for Customary Initiation as contained in the Schedule hereto, for public comment.

The proposed determinations aim to establish norms and standards for regulating fees for customary initiation practices. The draft determination contains two options: operating costs, stakeholder input, affordability, and cultural differences amongst ethnic groups. Option 1 sets out a standardised fee to be applied across all provinces, while Option 2 outlines province-specific fees applicable only within the respective provinces and caters for provincial peculiarities.

Submissions to the Department should clearly state the preferred option, if any, and detailed reasons for the choice. The deadline for submitting comments is **90** calendar days from the date of publication of this notice in the Gazette. All comments must be submitted in the specified format outlined below:
