APPLICATION FOR REGISTRATION OF HERALDIC REPRESENTATIONS AND OBJECTIONS THERETO
SECTIONS 7, 7A AND 7B OF THE HERALDRY ACT, 1962 (ACT NO. 18 OF 1962)

The under-mentioned bodies and persons have applied in terms of section 7 of the Heraldry Act, 1962 (Act No. 18 of 1962), for the registration of their heraldic representations. Anyone wishing to object to the registration of these heraldic representations on the grounds that such registrations will encroach upon rights to which he or she is legally entitled should do so within one month of the date of publication of this notice upon a form obtainable from the State Herald, Private Bag X236, Pretoria, 0001.

1. APPLICANT: **Titus Lebohang Nare** (H4/3/4/1066)

ARMS: Tierced per fess, in fess the underside enarched, Tenné, a sorghum head slipped on a staff and a spear in saltire proper, debriused by an African drum proper; in chief dexter, barry wavy of seven Argent and Azure, and in chief sinister, barry dancetty of seven Or and Sable, overall an inverted isosceles triangle throughout Vert, charged with a pickaxe erect proper; in base Or, a buffalo's head caboshed proper, beneath it a dove close proper.

CREST: Issuant from a zebra-skin traditional head-ring, a baobab tree proper.

WREATH AND MANTLING: Vert and Or

MOTTO: AHEE BABIRWA WEE

2. APPLICANT: **Freddie Vermeulen** (H4/3/4/1068)

ARMS: Argent, on a chevron Azure, to dexter a tiger passant guardant proper, and to sinister a lion passant guardant Or, in chief to dexter a windmill Or, its sails Gules, to sinister five four-pointed mullets Gules, four smaller and one larger, in base an olive tree proper.

CREST: Within a laurel wreath Or, a sun Gules.

WREATH AND MANTLING: Azure and Argent.

MOTTO: OMNIS HONOR DEO

3. APPLICANT: **Leon Visagie Louw** (H4/3/4/1069)

ARMS: Tierced per fess: in chief Gules, a chevron inverted embowed Argent, thereon a Protea flower Gules, slipped and leaved Vert; the fess Sable, masoned Argent, its underside enarched; in base Argent, a Laurel tree proper.

CREST: A lion rampant Or, holding between its paws a compass rose Argent and Sable.

WREATH AND MANTLING: Gules and Argent.

MOTTO: PER CONSTANTIAM AD PROSPERITATEM

4. APPLICANT: **Mkhululi Duncan Stubbs** (H4/3/4/1070)

ARMS: Gules, a saltire Vert, fimbriated Or. Behind the shield, a spear erect proper, atop it a balance Or, its weighing plates Azure. The shield is flanked on either side by a laurel wreath Vert.

MOTTO: NUNQUAM VICTUS

5. APPLICANT **James Michael Moodie** (H4/3/4/1071)

ARMS: Azure, a saltire Argent, in chief a Maltese cross Argent, in base a rod of Asclepius of the second, in dexter a garb Or, and in sinister a three-masted barque proper.

CREST: A lion passant Or, langued Gules, collared Azure fimbriated Or, charged on the collar with three Maltese crosses Argent.

WREATH AND MANTLING: Azure and Argent.

MOTTO: SERVE CUM CURA
