NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008 (ACT NO. 59 OF 2008)

PROPOSED AMENDMENTS TO THE NATIONAL WASTE INFORMATION REGULATIONS, 2012

I, Dion Travers George, Minister of Forestry, Fisheries and the Environment, hereby in terms of section 69(1)(t), (y)(aa) and (ee), read with sections 72 and 73 of the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008), give notice of my intention to amend the National Waste Information Regulations, 2012, published under Government Notice No. R.625, Government Gazette No. 35583 of 13 August 2012, as set out in the Schedule hereto.

Members of the public are invited to submit written representations or objections, within 30 days from the date of publication of this notice in the Government *Gazette* or in the newspaper, whichever is the later date, to any of the following addresses:

SCHEDULE

Definitions

- 1. In this Schedule, any word or expression to which a meaning has been assigned in the Act bears that same meaning, and unless the context indicates otherwise
 - **"the Regulations"** means the National Waste Information Regulations, 2012, published under Government Notice No. R.625 of Government *Gazette* No. 35583 on 13 August 2012.

Amendment of regulation 1 of the Regulations

- Regulation 1 of the Regulations is hereby amended by —
- (a) the deletion of the definition of "these Regulations"; and
- (b) the insertion after the definition of "the Act", of the following definition:
 - "transporter of waste for gain" means a person whose business involves transporting waste using a motorised vehicle or locomotive and who receives a direct income from transporting waste, excluding where the transportation of waste is by a municipality;";

Amendment of regulation 3 of the Regulations

- 3. Regulation 3 of the Regulations is hereby amended by the insertion after subregulation (3), of the following subregulation:
 - "(4) These Regulations do not apply to mining residue stockpiles or residue deposits."

Amendment of regulation 5 of the Regulations

- **4.** Regulation 5 of the Regulations is hereby amended by —
- (a) the substitution for subregulation (3) of the following subregulation:
 - "(3) Where a person referred to in subregulation (1) conducts more than one activity in different facilities or the same facility, such activities must be registered individually.".
- (b) the insertion after subregulation (4), of the following subregulation:
 - "(5) A person registered as a waste transporter for gain must comply with section 25 of the Act.".

Amendment of regulation 6 of the Regulations

- 5. Regulation 6 of the Regulations is hereby amended by —
- (a) the substitution for subregulation (1)(a), of the following subregulation:
 - "(a) register the applicant and issue a registration certificate to the applicant which contains-

- (i) name of the activity;
- (ii) a waste information registration number;
- (iii) waste management method or hazardous waste generator;
- (iv) the date of registration; and
- (v) date of expiry; or";
- (b) the insertion, after subregulation (1)(b), of the following subregulations:
 - "(c) the registration certificate issued in (a) is valid for three years from the date of issue; thereafter, it may be renewed, provided a registered person complies with the provisions of regulation 8."; and
 - "(d) the Department may withdraw the registration certificate if it believes that a registered person is not complying with the provisions of the Regulations.".

Amendment of regulation 7 of the Regulations

- Regulation 7 of the Regulations is hereby amended by —
- (a) the substitution for subregulation (5) of the following subregulation:
 - "(5) the Department may withdraw the registration certificate if it believes that the activity is no longer applicable, or if a registered person is not complying with the provisions of these Regulations.".
- (b) the insertion after subregulation (5), of the following subregulations:
 - "(6) If a person intends to recommence an activity for which the registration was withdrawn, the person must comply with the legal requirements set out in regulation 5.".
 - "(7) the Department may reinstate an activity that has been withdrawn, subject to reasons provided.".

Amendment of regulation 8 of the Regulations

- 7. Regulation 8 of the Regulations is hereby amended by
 - (a) the substitution for subregulation (1), of the following subregulation:
 - "(1) The submission of information to the SAWIS commences ninety (90) days after the end of the registration period contemplated in regulation 5(1).".
 - (b) the substitution for subregulation (3), of the following subregulation:
 - "(3) Subregulations (1) and (2) do not apply to the registered generators of hazardous waste and registered transporters of waste for gain.".
 - (c) the substitution for subregulation (9) of the following subregulation:

"(9) If a registered person cannot submit the required information to the SAWIS, a registered person must submit the required information to the Department within sixty (60) days of the end of a reporting period."

Amendment of regulation 9 of the Regulations

- **8.** Regulation 9 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:
 - "(2) the record contemplated in subregulation (1) must -
 - (a) include but not limited to, calibration certificate, source documents, such as weighbridge/scale slips, waste manifest documents, and daily records of waste transactions that inform the monthly tonnages reported to the SAWIS, where applicable;
 - (b) be retained for a period of at least five (5) years, and
 - (c) be made available for an inspection by a representative of the Department, on request."

Amendment of regulation 11 of the Regulations

Regulation 11 of the Regulations is hereby amended by the insertion after subregulation (11), of the following regulation:

"Transitional arrangements"

"11A. Any person who conducts a new or an amended activity listed in Annexure 1, must apply to register in terms of regulation 5 of these Regulations, before 30 September 2025."

Amendment of regulation 12 of the Regulations

- **10.** Regulation 12 of the Regulations is hereby amended by the substitution for regulation 12, of the following regulation:
 - "12. Offences and penalties. (1) A person commits an offence if that person —
 - (a) provides incorrect or misleading information to the SAWIS or the Department; or
 - (b) fails to comply with regulations 3(2), 4; 5(1), (2), (3), (4), (5), 6(2), 7(1), (2), (3), (5), 8(1), (2), (4), (5), (8), (9) or 9.";
 - (2) A person who commits an offence in terms of subregulation (1) is liable on conviction to —
 - (a) imprisonment for a period not exceeding five years or a fine not exceeding five million rand, and
 - in the case of a second or subsequent conviction, to a fine not exceeding 10 million rand, or

"(c) imprisonment for a period not exceeding 10 years or in both instances to both a fine and such imprisonment."

Amendment of regulation 13 of the Regulations

11. Regulation 13 of the Regulations is hereby amended by the substitution for regulation 13 of the following regulation:

"These Regulations are called the National Waste Information Regulations, 2012 and will take effect on the date of publication for implementation by the Minister in the Government Gazette."

Amendment of the Table of Contents of the Regulations

12. The Table of contents of the Regulations is hereby amended by the insertion after content **11**, of the following content:

"11A. Transitional arrangements.".

Amendment of Annexure 1 of the Regulations

13. Annexure 1 of the Regulations is hereby amended by the substitution for Annexure 1, of the following Annexure:

"ANNEXURE 1

LIST OF PERSONS CONDUCTING THE FOLLOWING ACTIVITIES MUST APPLY TO BE REGISTERED ON THE SAWIS IN TERMS OF REGULATION 5

Generators of waste

(a) Generators of hazardous waste in excess of 20kg per day, calculated as a monthly average.

Recovery or recycling of waste

- (b) Recovery of energy from general waste at a facility that has the capacity to process in excess of three tonnes of general waste per day.
- (c) Recovery of waste at a facility that has the capacity to process in excess of 10 tonnes of general waste or in excess of 100kg of hazardous waste per day, excluding recovery that takes place as an integral part of an internal manufacturing process within the same premises and excluding where the recovered waste will be sent for recycling but including where the recovered waste will be exported.
- (d) The scrapping or recovery of motor vehicles at a facility that has an operational area in excess of 500m².
- (e) Recycling of general waste at a facility that has an operational area in excess of 500m².
- (f) Recycling of hazardous waste in excess of 100kg per day, calculated as a monthly average.

Treatment of waste

- (g) Treatment of waste using any form of treatment at a facility that has the capacity to process in excess of 10 tonnes of general waste or 100kg of hazardous waste per day, excluding the treatment of effluent, wastewater, or sewerage.
- (h) Treatment of health care risk waste regardless of size or capacity of the facility.

Disposal of waste

- (i) Disposal of general waste to land covering an area in excess of 200m².
- (j) Disposal of any quantity of hazardous waste to land.

Exportation of hazardous waste

(k) Hazardous waste exported from the Republic of South Africa.

Transportation of waste

(I) Transportation of waste for gain."

Amendment of Annexure 2 of the Regulations

14. Annexure 2 of the Regulations is hereby amended by the substitution for Annexure 2, of the following Annexure:

"ANNEXURE 2

REPORTING REQUIREMENTS IN TERMS OF REGULATION 8

The required quarterly information for reporting to the SAWIS, read with Annexure 1 of these Regulations, must include—

- (a) The month and year to which the information applies;
- (b) Categories of waste as detailed in Annexes 3 and 4;
- (c) Source from which waste comes; and
- (d) The quantity of waste reported in tonnes."

Amendment of Annexure 3 of the Regulations

15. Annexure 3 of the Regulations is hereby amended by the substitution for Annexure 3, of the following Annexure:
