The South African Heritage Resources Agency (SAHRA) may recover costs for services rendered in terms of the provisions of section 25(2) of the National Heritage Resources Act, No. 25 of 1999 (NHRA). Applications submitted to SAHRA must be accompanied by proof of payment of fees listed in part B of this notice, taking effect from 1 August 2025 until further notice.

Exemptions may be granted at the discretion of the Chief Executive Officer of SAHRA per the Provisions of SAHRA's Policy on Levying Fees for Services.
