The Fund has a Board, whose function, amongst others, is to exercise the overall authority and control over the financial position, operation and management of the Fund. The Board serves for a period of three (3) years and is accountable to the Minister of Transport.

An invitation for nomination was published in the *Gazette* and national news media for nominations of persons to serve on the RAF Board. The deadline for submission of nominations was 11 August 2025.
