## DECLARATION OF CONTROLLED MINES AND RISK WORK

I, Dr PA Motsoaledi, Minister of Health, hereby in terms of section 10 of the Occupational Diseases in Mines and Works Act, 1973 (Act No. 78 of 1973), declare the following mines to be controlled mines with effect from 1 November 2025:

- a) The mine known as **Chilwavhusiku Colliery** on Portions 71,72,73 and 77 of the farm Wachtenbietjeskop 506 JR, Portions 1,13,14 and 15 of the farm Tweefontein 491 JR, near eMalahleni in the province of Mpumalanga;
- b) The mine known as **Demaneng Mine** on Portion 1 of the farm Mashwening 557, near Kuruman in the province of the Northern Cape;
- c) The mine known as **Nkomati Anthracite Mine** situated on Stateland Unsurveyed Sikhwahlane, near Komatipoort in the province of Mpumalanga;
- d) The mine known as **Glenover Mine** on the farms Glenover 371 LQ and Glenover 43, near Thabazimbi in the province of Limpopo;
- e) The mine known as **Mototolo Mine** on Portion 1 of the farm Thorncliffe 374 KT near Mashishing in the province of Mpumalanga;
- f) The mine known as **Elders Colliery** on Portion 3 of the farm Vlakkuijen 76 IS, near Bethal in the province of Mpumalanga;
- g) The mine known as **Dwarsrivier Chrome Mine** on the farm Dwarsrivier 372 KT, near Sekhukhune in the province of Limpopo;
- h) The mine known as **Moeijelijk Mine** on the farm Moeijelijk 412 KS, near Mashishing in the province of Mpumalanga;
- i) The mine known as **Frischgewaagd Chrome Mine** on the farm Frischgewaagd 359 KT, near Steelpoort in the province of Limpopo;
- j) The mine known as **Elandskraal Mine** on Portion 2 of the farm Elandskraal 469 JQ, near Mooiooi in the province of the North West;
- k) The mine known as **De Groote Boom Mine** on the farm De Grooteboom 373 KT in the district of Sekhukhune and in the province of Limpopo;
- l) The mine known as **Modderfontein Gold Mine** on the farm Modderfontein 76 IR near Springs in the province of Gauteng;
- m) The mine known as **Kalagadi Manganese Mine** on the farms Umtu 281, Olive Pan 282 and Gama 283 near Kuruman in the province of the Northern Cape;
- n) The mine known as **Kropz Elandsfontein Mine** on Portions 2 and 4 of the farm Elandsfontein 349, near Vredenburg in the province of the Western Cape;
- o) The mine known as **Langpan Mining Company** on the farm Langpan 317 KQ near Thabazimbi in the province of Limpopo;
- p) The mine known as **Mokala Manganese Mine** on the farm Gloria 266, near Kathu in the province of the Northern Cape;
- q) The mine known as **Gardinia Colliery** on the farm Gardinia 8486 HS, near Newcastle in the province of KwaZulu-Natal;
- r) The mine known as **Nokeng Fluorspar Mine** on Portions 2, 4 and 11 of the farm Kromdraai 209 JR and Portion 1 of the farm Naauwpoort 208 JR, near Cullinan in the province of Gauteng;
- s) The quarry known as **Eedeswold Quarry** on Subdivision 9 of the farm Eedeswold 5129, near Port Shepstone in the province of KwaZulu-Natal;


- t) The mine known as **Sedibeng Iron Ore Mine** on the Remainder of the farm Klipfontein 437 and Portion 3 of the Farm 445, near Postmasburg in the province of the Northern Cape;
- u) The mine known as **Klipspruit Colliery** on Portion 12 of the Farm Klipfontein 3 IS, near Ogies in the province of Mpumalanga;
- v) The mine known as **Brakfontein Colliery** on Portions 17 and 27 on the farm Brakfontein 264 IR, near Delmas in the province of Mpumalanga;
- w) The mine known as **Fairbreeze Mine** on the farms Umlazi 10011 GU Lot 91 and Garland 15475 GU 1 and 2, near Empangeni in the province of KwaZulu-Natal;
- x) The mine known as **Tronox Namakwa Sands Northern Operations** on the farm locations Portions 1, 2 and 3 of Hartebeeste Kom 156; Portion 17 of Goeraap 140; Portions 1, 2 and the remaining extension of Rietfontein Ext 151; Portions 1, 2 and the remaining extension of Graauw Duinen 152; Portions 2, 5 and the remaining extension of Portion 2 of Houtkraal 143 near Empangeni in the province of KwaZulu-Natal;
- y) The mine known as **Botleng Colliery** on Portion 4 of the farm Leeuwpoort 205 IR, near Delmas in the province of Mpumalanga; and
- z) The mine known as **Boskop Mine** on Portion 1 of the farm Macarthy 559, near Kuruman in the province of the Northern Cape.

I hereby, in terms of section 13 of the said Act, declare the following work at the said mines to be risk work with effect from the same date:

Excavations: Any work in underground or open workings.

On the surface: Any work-

- (i) at surface bins;
- (ii) where the moving, transfer or handling of stone, rock, ore, coal or other minerals takes place, including any loading operation at subsidiary sidings;
- (iii) where the crushing, screening or classification of stone, rock, ore, coal or other minerals takes place, except where this is carried out under water;
- (iv) at tube mill plants, rotary filter plants and smelt-houses;
- (v) on or at waste dumps, ore dumps, coal dumps or slimes dams, except where the materials are being deposited in the form of slime;
- (vi) in blacksmith shops, boilermaker shops, truck repair shops, welding shops and drill-sharpening shops or at any other place where drills are sharpened;
- (vii) in change-houses where persons performing risk work change their clothing;
- (viii) in assay laboratories and coal laboratories, except separately ventilated parts thereof where only wet assays are done and no treatment of dry stone, rock, ore, coal or other minerals takes place;
- (ix) where samples of crushed ore, coal or other minerals are graded in a dry state; and
- (x) where rock drilling is done.
