REPUBLIC OF SOUTH AFRICA**CALL FOR NOMINATIONS TO FILL TWO VACANCIES ON THE BOARD OF THE NATIONAL LOTTERIES COMMISSION (NLC)**

The Lotteries Act, 1997 (Act No 57 of 1997) (the Act), as amended established the NLC to regulate and prohibit lotteries and sport pools, and administer the National Lottery Distribution Trust Fund. The NLC is governed by the Board appointed in accordance with the provisions of this Act.

The Minister of Trade, Industry and Competition hereby invites nominations of persons to fill the following two vacancies:

1. Chairperson of the Board;
2. Member of the Board (with gaming and lotteries experience)

Composition of the NLC Board: In terms of section 3 of the Act, the Minister shall appoint the members of the Board which shall consist of-

(a) a chairperson who shall be a person with applicable knowledge or experience with regard to matters connected with the functions of the board:

(b) one member designated by the Minister: and

(c) not more than five members who have proven business acumen or applicable knowledge or experience with regard to matters connected with the functions of the board, and of whom at least one should be a legal practitioner admitted to practise in the Republic and at least one a chartered accountant in the Republic.

Disqualification, conflict of interest and confidentiality and restraint of trade:

Nominees should ensure that they are not disqualified for membership of the NLC, nor conflicted and comply with the confidentiality and restraint of trade clauses as outlined in the provisions of section 3A, 3B and 3C of the Act as well as section 33 of the Constitution of the Republic of South Africa, respectively.

Term of office: A member of the board shall hold office for such period, not exceeding five years as the Minister may determine at the time of his or her appointment, and shall be eligible for reappointment at the end of his or her first term of office.

Remuneration: Rates as determined and published by the National Treasury.

Nomination Procedure: Nominations must contain the following information: Detailed curriculum vitae that includes membership of all boards the nominee currently serves on or has served on in the past, motivation for the appointment and certified copies of the identity document and qualifications obtained. Verification of foreign qualifications by the South African Qualifications Authority (SAQA).

The following **mandatory** forms which are obtainable from **the dtic** website, <https://www.thedtic.gov.za/board-ceo-commissioners-vacancies/> must be fully completed, signed, and submitted: • Nomination and nomination acceptance form (Form 1A) • Particulars of the nominee form (Form 1B) • Criminal record and indemnity declaration form • Consent form • Register of interest information sheet.

In addition: Background verification, including criminal record and citizenship checks, will form part of the selection process • It is the nominee's responsibility to have foreign qualifications verified by SAQA.

A member of the board shall, before appointment, submit to the Minister a written statement in which he or she declares whether or not he or she has any direct or indirect interest, financially or otherwise, whether or not such interest-

- (a) may constitute a conflict of interest in respect of his or her functions as a member of the board; or
(b) could reasonably be expected to compromise the board in the performance of its functions.
