**DECLARATION AMENDMENT OF PART OF EXISTING NATIONAL ROAD N1 SECTION 29X AS
NATIONAL ROAD R572 SECTION 5****AMENDMENT OF DECLARATION No. 330 OF 2018**

By virtue of section 40(1)(b) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), I hereby amend Declaration No. 330 of 2018 by changing a part of the route's number from National Road N1 Section 29X to National Road R572 Section 5, being the part of the route commencing from its Junction with the northern intersection of the exiting Musina Ring Road, from there it follows the street known as national Road in a general eastern and then southern direction, at time of declaration, up to the intersection with Road R508 and the street known as Irwin Street, at the time of declaration, in the Town of Musina.
