PROCLAMATION NOTICE 293 OF 2025

**by the
PRESIDENT of the REPUBLIC of SOUTH AFRICA**

SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): AMENDMENT OF PROCLAMATION NO. R. 32 OF 2020 - THE NATIONAL LOTTERIES COMMISSION

Under section 2(4) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby amend Proclamation No. R. 32 of 2020 (hereinafter referred to as “the original Proclamation”), by the—

- (a) extension of end date mentioned in paragraph 4 of the body of the original Proclamation (6 November 2020, being the date of publication of the original Proclamation) to date of publication of this Proclamation;
- (b) insertion after paragraph 1 of the Schedule to the original Proclamation of the following paragraph:
 - “2. The procurement of or contracting for—
 - (a) the appointment of a panel of attorneys’ firms and legal practitioners in terms of Bid NLC/2020-05;
 - (b) the appointment of a service provider for a Comprehensive Employee Wellness Programme for the Employees of the NLC in terms of RFP/2021-15;
 - (c) the extension of the appointment of Metrofile for offsite storage of documents and delivery thereof from 1 January 2021 to 31 March 2021;
 - (d) the appointment of a service provider for the Procurement of Electronic Board Pack in terms of RFP/2020-06, RFQ NLC/2019-006 and Bid NLC 2020-006;
 - (e) the appointment of a service provider for advertorial on Back to Basics Magazine;
 - (f) submission for approval: deviation from normal procurement process, Independent Media, Arena Holdings, Media 24;
 - (g) the appointment of Mail & Guardian for media road show through a deviation from normal competitive bidding;
 - (h) a contract with a service provider for the provision of MPLS services on 12 May 2016;
 - (i) a Service Level Agreement for the rental of managed print services for the period 1 June 2018 to 31 May 2021;

- (j) appointment of service provider for travel, accommodation and conferencing as it relates to the fourth licence RFP process;
- (k) placement of advertorials in the Sunday World newspaper;
- (l) a flashmob activation (Women 2021 Celebrations) involving MSG Group Sales, and Elscope Digital Solutions;
- (m) the appointment of Neo Solutions in October 2017 for the development of a Company Secretariat Knowledge Hub Strategy;
- (n) the appointment of Neo Solutions to investigate a potential hacking incident involving the electronic board pack;
- (o) the appointment of Edge Consulting in June 2019 for the implementation of an Oracle Fusion System;
- (p) the appointment of ProEthics to provide services in relation to ethics;
- (q) the appointment of Workforce Healthcare in September 2019 for the provision of employee wellness services;
- (r) the appointment of SRSQS Quantity Surveyors in January 2018 for project managing the acquisition of provincial offices;
- (s) the appointment of Maluks Attorneys in April 2021 to a panel of legal service providers;
- (t) an education and awareness broadcast campaign related to the purchase order dated 29 October 2020; and
- (u) accommodation and travel services rendered by Regency Apartment Hotel and Ndila Transfers,

by or on behalf of the NLC, and payments which were made in respect thereof in a manner that was—

- (i) not fair, equitable, transparent, competitive or cost-effective; or
- (ii) contrary to applicable—
 - (aa) legislation;
 - (bb) manuals, guidelines, practice notes, circulars or instructions issued by the National Treasury; or
 - (cc) manuals, codes, guidelines, policies, procedures, prescripts, instructions or practices of, or applicable to the NLC,

and any related unauthorised, irregular or fruitless and wasteful expenditure incurred by the NLC or the State.”;

- (c) substitution in paragraph 2 of the Schedule to the original Proclamation for the expression “paragraph 1” of the expression “paragraphs 1 and 2”; and
- (d) consequential re-numbering of the existing paragraph 2 in the Schedule to the original Proclamation to paragraph 3.

(WET NO. 74 VAN 1996): WYSIGING VAN PROKLAMASIE NO. R. 32 VAN 2020 –
DIE NASIONALE LOTERYEKOMMISSIE**

Kragtens artikel 2(4) van die Wet op Spesiale Ondersoekeenhede en Spesiale Tribunale, 1996 (Wet No. 74 van 1996), wysig ek hierby Proklamasie No. R. 32 van 2020 (hierna na verwys as die “oorspronklike Proklamasie”), deur—

 - (a) aanstelling van ‘n paneel van prokureurs firmas en regspraktisyns ingevolge Bod NLC/2020-05;
 - (b) die aanstelling van ‘n diensverskaffer vir ‘n “Comprehensive Employee Wellness Programme” vir die Werknemers van die NLK ingevolge RFP/2021-15;
 - (c) die verlenging van die aanstelling van Metrofile vir van die werf af stoorplek van dokumente en aflewering daarvan vanaf 1 Januarie 2021 tot 31 Maart 2021;
 - (d) die aanstelling van ‘n diensverskaffer vir die “Procurement of Electronic Board Pack” ingevolge RFP/2020-06, RFQ NLC/2019-006 en Bod NLC 2020-006;
 - (e) die aanstelling van ‘n diensverskaffer vir ‘n advertensie op Back to Basics Tydskrif;
 - (f) aanbeveling vir toestemming: afwyking van normale aanskaffing proses, Independent Media, Arena Holdings, Media 24;
 - (g) die aanstelling van Mail & Guardian vir ‘n media promosietoer deur ‘n afwyking van normale kompeterende bod;
 - (h) ‘n kontrak met ‘n diensverskaffer vir die verskaffing van MPLS dienste op 12 Mei 2016;

- (i) 'n Diensleweringsooreenkoms vir die huur van bestuurde druk dienste vir die tydperk 1 Junie 2018 tot 31 Mei 2021;
 - (j) aanstelling van diensverskaffer vir reis, verblyf en konferensie aangesien dit verwant is aan die vierde lisensie "RFP" proses;
 - (k) plasing van advertensies in die Sunday World koerant;
 - (l) 'n kitskare aktivering (Vroue 2021 Vieringe) wat MSG Group Sales, en Elscope Digital Solutions betrek het;
 - (m) die aanstelling van Neo Solutions in Oktober 2017 vir die ontwikkeling van 'n "Company Secretariat Knowledge Hub Strategy";
 - (n) die aanstelling van Neo Solutions om ondersoek in te stel na die potensiële inbreukmaking insident wat die elektroniese bord pak betrek het;
 - (o) die aanstelling van Edge Consulting in Junie 2019 vir die implimentering van 'n "Oracle Fusion System";
 - (p) die aanstelling van ProEthics om dienste in verband met etiek te verskaf;
 - (q) die aanstelling van Workforce Healthcare in September 2019 vir die verskaffing van werknemer welstand dienste;
 - (r) die aanstelling van SRSQS Bourekenaars in Januarie 2018 vir projekbestuur van die verkryging van provinsiale kantore;
 - (s) die aanstelling Maluks Prokureurs in April 2021 tot 'n paneel van regsdiensverskaffers;
 - (t) 'n opvoeding en bewusmakings uitsaai projek met betrekking tot die aankoop bestelling gedateer 29 Oktober 2020; en
 - (u) verblyf en reisdienste verskaf deur Regency Apartment Hotel en Ndila Transfers, deur of namens die NLK, en betalings wat ten opsigte daarvan gemaak is op 'n wyse wat—
 - (i) nie regverdig, gelykmatig, deursigtig, kompiterend of koste-effektief was nie; of
 - (ii) strydig was met toepaslike—
 - (aa) wetgewing;
 - (bb) handleidings, riglyne, omsendskrywes of instruksies wat deur die Nasionale Tesourie uitgevaardig is; of
 - (cc) handleidings, beleid, prosedures, voorskrifte, instruksies of praktyke van, of wat op die NLK van toepassing is,
- en enige verwante ongemagtigde, onreëlmatige, of vrugtelose en verkwiste uitgawes wat aangegaan is deur die NLK of die Staat.”;

- (c) vervanging in paragraaf 2 in die Bylae tot die oorspronklike Proklamasie vir die uitdrukking “paragraaf 1” van die uitdrukking “paragrafe 1 en 2”; en
- (d) die gevolglike hernoemering van die bestaande paragraaf 2 in die Bylae tot die oorspronklike Proklamasie na paragraaf 3.
