NOW THEREFORE NOTICE is hereby given in terms of Section 11A(2) of the Act that at the expiry of 90 days from the date of the publication of this notice in the Government Gazette, the notice of the claim previously published in terms of section 11(1) of the Act in Gazette No.48187, under Notice 1662 of 2023, dated March 2023, to the extent that it relates to the properties listed below, will be withdrawn unless cause to the contrary is shown to the satisfaction of the Regional Land Claims Commissioner.
