

BOARD NOTICE 854 OF 2025**SOUTH AFRICAN NURSING COUNCIL****Nursing Act, 2005 (Act No. 33 of 2005)****NOTICE REGARDING PROPOSED FEES FOR ACCREDITATION OF CONTINUING PROFESSIONAL DEVELOPMENT (CPD) PROVIDERS PAYABLE TO THE SOUTH AFRICAN NURSING COUNCIL****DEFINITION**

1. In this notice, **CPD** as defined in the CPD framework is a "purposeful statutory process whereby registered practitioners registered with SANC, through personal commitment, engage in a range of learning activities/events/programmes to maintain and improve their knowledge, skills, attitudes and professional integrity to keep up to date with new science, innovation and health care developments; to enable them to practise safely, ethically, competently, and legally within their evolving scope of practice; and to provide quality care to the South African community.
2. Section 39 of the Nursing Act, 2005 (Act No. 33 of 2005) mandates Council to determine the criteria for recognition by the Council of CPD and accredited institutions offering such activities and fees payable.
3. In this notice, "**the regulations**" means the Regulations Regarding Fees and Fines Payable to the South African Nursing Council published by Government Notice No. R. 170 of 8 March 2013.

PROPOSED FEES FOR ACCREDITATION OF CPD PROVIDERS

1. The proposed fees are informed by the costing report on Evaluation and Analysis, benchmarking report conducted, fees charged by statutory Councils with the same mandates for accreditation/approval of CPD programmes,
2. The proposed fees differentiate between the cost of application for accreditation for a full programme and the cost of application for accreditation for a short course

3. A full programme refers to an application by a prospective CPD provider to offer a full scale of CPD activities **across all five themes** and a short course is an application by a prospective provider to offer focussed CPD activities in one of the five themes by someone specialised e.g. an application by a provider to offer Ethics under Ethical and Legal theme.

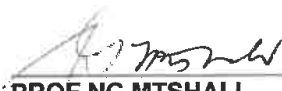
