PROPOSED AMENDMENTS TO

PUBLIC SERVICE AMENDMENT BILL

CLAUSE 1

1. On page 3 in line 3, to delete the expression “**“head of department”, “head of a department” or “head of the department”**” and to substitute with the expression “**‘head of department’, ‘head of a department’ or ‘head of the department’**”.
2. On page 3 in line 9, to delete the words “**“political office”**” and to substitute with the words “**‘political office’**”.
3. On page 3, in line 12, after the word “secretary”, to insert “,” and to omit the word “or”.
4. On page 3, in line 12, after the word “party”, to insert the words “or membership of a party’s executive committee”.

CLAUSE 2

1. On page 3, in line 44, after the word “and”, to omit the word “must” and to substitute with the word “shall”.
2. On page 3, in line 56, after the word “authority”, to omit the word “must” and to substitute with the word “shall”.

CLAUSE 4

1. On page 4, in line 50, to omit the word “must” and to substitute with the word “shall”.

CLAUSE 12

1. On page 8, in line 47, to omit the expression “section 41(1)[(b)](v)” and to substitute with the expression “section 41(1)(b)(v)”.

CLAUSE 13

1. On page 9, from line 17, to omit paragraph (c) and to substitute with the following paragraph:

“(c)by the substitution for subsection (3) of the following subsection:

“(3) For the purposes of subsection (1)(a)(i)—

- (a) **‘this Act’** includes any law repealed by this Act;
- (b) **‘determination of the Minister’** includes any recommendation of the [Public Service] Commission, [established by section 209 (1) of the Constitution of the Republic of South Africa, 1993 (Act 200 of 1993), or of] any commission for administration[, public service commission] or other like institution established by or

- under, or which functioned in accordance with, any such law; and
- (c) ‘**section 30[(b)]**’ includes any corresponding provision of any such law.”.

CLAUSE 14

1. On page 9, in line 33, to omit “(a)” and to substitute with “(a)”.

CLAUSE 16

1. On page 10, in line 12, to omit the word “must” and to substitute with the word “shall”.

CLAUSE 18

1. On page 10, in line 30, to omit the expression “subsection (2)” and to substitute with the expression “subsection (1)”.
2. On page 11, in line 6, after the expression “made;”, to insert the word “and”.
