**DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT****NOTICE 3865 OF 2026****THE EXTENSION OF ADDITIONAL SERVICES TO INCREASE ACCESS TO COURTS BY THE DISADVANTAGED COMMUNITIES**

The Department of Justice and Constitutional Development has a constitutional obligation to ensure everyone has access to courts. The Constitution further recognises the right of access to justice as a fundamental human right, which is a vital ingredient in the protection and enforcement of other human rights. In its endeavour to increase access to courts by the disadvantaged communities, the Department of Justice and Constitutional Development has undertaken an initiative to extend additional court services to the courts that are historically serving as satellite points for larger magistrates' courts. This initiative is aimed at bringing justice services closer to rural and township communities, reducing travelling time and cost, and alleviating the caseloads at the main courts.

The courts listed under Column D of the Schedule, will with effect from **31 March 2026**, provide the list of additional services as mentioned under Column E of the same Schedule. These extended services further advance the Department's commitment to ensure accessible justice services to all. Communities in these areas are encouraged to take advantage of these extended services to resolve legal disputes.
