**NOTICE OF PUBLICATION OF MUNICIPAL ELECTRICITY TARIFF APPLICATIONS FOR THE 2026/27 FINANCIAL YEAR**

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), the Gas Act, 2001 (Act No. 48 of 2001) and the Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

NERSA has commenced with the receipt of municipal electricity tariff applications as part of the annual tariff review process. In line with its regulatory procedures, all tariff applications received will be published on the NERSA website and its social media platforms to invite written comments from affected stakeholders and members of the public. These applications can be accessed under [www.nersa.org.za](http://www.nersa.org.za) >Electricity>Pricing>Local Authorities & Private Distributors

The final decisions on the tariff applications will be taken after due consideration of the written submissions received from stakeholders, together with the technical and regulatory analysis conducted.
