Notice of Forfeiture to the State of money and/or goods in terms of the provisions of Exchange Control Regulation 22B made under Section 9 of the Currency and Exchanges Act, 1933 (Act No. 9 of 1933), as amended, as promulgated by Government Notice No. R.1111 of 1961-12-01 in respect of the money and/or goods of:

**Be pleased to take notice that:**

1. The Minister of Finance of the Republic of South Africa has, by virtue of the provisions of Exchange Control Regulation 22E delegated all the powers and functions conferred, and duties imposed, on the Treasury by the provisions of the Exchange Control Regulations (with the exception of the functions and/or powers conferred upon the Treasury by Exchange Control Regulations 3(5), 3(8), 20 and 22, but which exception does not include the functions and/or powers under Exchange Control Regulations 22A, 22B, 22C and 22D), to, *inter alios*, the Governor or any Deputy Governor of the South African Reserve Bank.
2. By virtue of the functions, powers and/or duties vested in me, in my capacity as a Deputy Governor of the South African Reserve Bank, in terms of the delegation and assignment of the functions, powers and/or duties referred to in paragraph 1 above, I hereby give notice of a decision to forfeit to the State the following money and/or goods and I hereby declare and order forfeit to the State the following money and/or goods, namely:
  - 2.1 The amount of R1 080 043.51, being capital standing to the credit of the Respondent in a fixed deposit account with account number 1100041823450, held with Investec Bank Limited, together with any interest thereon or any other accrual thereto.
  - 2.2 Erf 263 Val De Vie, in the Drakenstein Municipality, Division Paarl, Province of the Western Cape, held under Title Deed number T69375/2011 with a last known municipal value of R8 725 000.00, together with any accrual thereto.

- 2.3 Section No. 32 in the scheme known as Val De Vie Storage Facility, held under Title Deed number ST23514/2017 with a last known municipal value of R360 000.00, together with any accrual thereto.
  - 2.4 White 2019 model Toyota Fortuner with registration number CJ77098, Chassis/VIN number AHTKA3FSX00622351 and register number HLD961L – with an estimated value of R504 000.00.
  - 2.5 White 2014 BMW 3 Series with registration number CJ29973, Chassis/VIN number WBA3B16040NS53858 and register number TRJ768W – with an estimated value of R140 000.00.
  - 2.6 White 2015 Toyota Auris XR CVT with registration number CJ52750, Chassis/VIN number JTNKP3JE10J500318 and register number GGX146L – with an estimated value of R160 000.00.
  - 2.7 White 2011 Jurgens LT670 trailer with registration number CJ75910, Chassis/VIN number AAJLT670LBJ392489 and register number BGN886V – value unknown.
3. The date upon which the money and/or goods specified in paragraph 2 above is hereby forfeited to the State is the date upon which this Notice and Order of Forfeiture is published in this *Gazette*.
  4. The money specified in paragraph 2 above shall be disposed of by deposit thereof into the National Revenue Fund.
  5. The goods specified in paragraph 2 above shall be realised in such manner as the South African Reserve Bank may deem fit and the proceeds thereof, shall be disposed of by deposit thereof into the National Revenue Fund.
  6. This Notice also constitutes a written order, as contemplated in Exchange Control Regulation 22B, in terms of which the money and/or goods specified in paragraph 2 above is hereby forfeited to the State.
