**NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008  
(ACT NO. 59 OF 2008)****CALL FOR NOMINATIONS OF SUITABLE PERSONS TO BE APPOINTED AS MEMBERS OF THE INTERIM INDUSTRY ADVISORY COMMITTEE IN TERMS OF REGULATION 12(2) OF THE WASTE TYRE REGULATIONS, 2017**

The Waste Management Bureau hereby calls for nominations of suitable persons to be appointed as members of the interim Industry Advisory Committee (IAC) to advise on governance and operational matters pertaining to the management of waste tyres until a new Industry Waste Tyre Management Plan (IndWTMP) is approved in terms of section 28 or section 29 of the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) (NEMWA).

Section 29(1) of the NEMWA provides that “*The Minister may, by notice in writing, require an industry waste management plan to be prepared by an organ of state, excluding a municipality, within a stipulated timeframe.*” On 29 November 2019, the Minister gave notice to the Council for Scientific and Industrial Research, an organ of state, in terms of section 29(1) of NEMWA, which notice required the development of an Industry Waste Tyre Management Plan (IndWTMP), which was subsequently submitted. After the completion of a public participation process during 2020, this Plan was approved by the Minister on 19 March 2024 and published in the *Government Gazette* for implementation (Government Notice No. 4542 in *Government Gazette* 50322 of 20 March 2024).

Regulation 11A of the Waste Tyre Regulations, 2017 provides that “*The Minister may establish an Industry Advisory Committee upon approval of an Industry Waste Tyre Management Plan to support the implementation of the plan.*” The Minister established the IAC and published the names of members of the IAC in the *Government Gazette* on 25 July 2024. The members of the IAC were all representatives of the organisations listed in terms of regulation 11A.

The IndWTMP was however withdrawn on 3 June 2025 in Government Notice No. 6273 in *Government Gazette* 52790.

Regulation 12 of the Waste Tyre Regulations, 2017 deals with arrangements in the event that a waste tyre management plan is withdrawn (amongst others). In terms of regulation 12(2) “*The Bureau may establish an interim Industry Advisory Committee with all affected industry to deal with governance and operational matters pertaining to the management of waste tyres during this transitional period until another industry waste tyre management plan is approved in terms of section 28 or 29 of the Act.*” It is accordingly necessary to establish an interim IAC to advise on governance and operational matters pertaining to the management of waste tyres, until such time that a new IndWTMP is approved.

Members of the public are invited to submit, within 30 (thirty) days from the date of the publication of this Notice in the *Government Gazette*, or a notice in the newspaper, whichever date is the later, written nominations of suitable persons to be appointed to serve as members of the interim IAC.

Nominated members may be a representative from any of the following organisations:

- l) National Treasury (NT)
- m) South African Local Government Association (SALGA)
- n) Recycling Association of South Africa (RASA)
- o) Waste tyre processing in the form of association
- p) Micro-collectors in the form of association
- q) Retreaders in the form of association
- r) Waste RDI Roadmap Implementation Unit (WRIU) from the Department of Science and Innovation
- s) Tyre Recycling Industry Association of South Africa (TRIASA)
- t) Cement & Concrete SA (CCSA).

Nominee(s) must have suitable experience or expertise in any of the following fields: Environmental waste, waste tyre processing, tyre retreaders, waste tyre manufacturing, retail motor industry. The nominee(s) must represent an association or organisation from the tyre industry.

Nominations must be submitted by means of a completed Nomination Form contained in the Schedule to this Notice as well as a Curriculum Vitae of the nominee which sets out the following:

- i. Personal details including full names, surname, race and gender of the nominee;*
- ii. Postal and residential address, and contact number(s) of the nominee;*
- iii. Particulars of the nominee's qualifications, experience and areas of expertise;*
- iv. Names and contact details of the referees, and*
- v. The association or organization in which they represent.*

The members of the interim IAC will be appointed in their personal capacities and must broadly represent South African society. Members will serve on a part-time voluntary basis for an interim period, effective from the date of establishment of the interim IAC until such time that the interim IAC is disestablished.

Nominations received after the closing date may be disregarded.

**Confirmation of the availability of the nominee is also required.**
