**LEGAL NOTICE: ALLIED HEALTH PROFESSIONS COUNCIL OF SOUTH AFRICA
ELECTIONS: CALL FOR NOMINATIONS FOR APPOINTED MEMBERS OF COUNCIL
WHO WILL ALSO SERVE ON PROFESSIONAL BOARDS**

In terms of the provisions of sub-regulation 4(1) of Regulations No R 127 of 12 February 2001 to the Allied Health Professions Act (63/1982) ("the Act"), notice is hereby given to call for nominations of five (5) persons to be appointed by the Minister of Health to serve on the Allied Health Professions Council of South Africa for the term of office 2026 to 2031. In terms of section 5(1)(b)(ii) and (iii) of the Act, the Minister of Health shall appoint to Council:

- One person who shall be appointed on account of his/her knowledge of the law; and
- Four persons as community representatives, who shall be appointed on account of expertise in the fields of health, education and welfare.

Nominations of persons received in terms of sub-regulations 4(3) and (4) of the Act shall be in writing, signed by the person making the nomination and shall provide that the nominee declares that he/she is not registered in terms of the Act, is a South African citizen residing within the Republic and is not an unrehabilitated insolvent. The nomination form shall be signed by the nominee indicating his/her acceptance of the nomination and willingness to serve on the Council should he/she be nominated. All nomination shall include a detailed curriculum vitae of the nominee. ELECTIONS: CALL FOR NOMINATIONS FOR ELECTED MEMBERS OF COUNCIL**

In terms of the provisions of sub-regulation 2(1) of Regulations No R 127 of 12 February 2001 to the Allied Health Professions Act (63/1982) ("the Act"), notice is hereby given to call for nominations of registered practitioners in the professions contemplated in section 5(1)(a) of the Act, to serve on the Allied Health Professions Council of South Africa for the term of office 2026 to 2031.

Nominations of persons received in terms of sub-regulations 2(2) and (3) of the Act shall:

- a) be in writing;
- b) be signed by the person making the nomination;
- c) state which profession the nominee is being nominated to represent on the council;
- d) provide for the nominee to declare that he or she complies with section 6(1) of the Act, in that:
 - (i) he or she is not an unrehabilitated insolvent;
 - (ii) he or she is not disqualified in terms of the Act or the Health Professions Act, 1974 from practising his or her profession; or
 - (iii) he or she is a South African citizen who is permanently resident in the Republic;
- e) be signed by the nominee as indication of his or her acceptance of the nomination and willingness to serve on the council should he or she be elected thereto; and
- f) be accompanied by the nominee's council registration number and a one page summary of his or her curriculum vitae.
