SUPERIOR COURTS ACT, 2013 (ACT NO. 10 OF 2013)**DETERMINATION OF THE AREAS UNDER JURISDICTION OF THE MAIN AND LOCAL SEATS OF THE DIVISIONS OF THE HIGH COURT OF SOUTH AFRICA**

1. I, Mmamoloko Kubayi, Minister of Justice and Constitutional Development, in terms of section 6(3)(a) and (c) of the Superior Courts Act, 2013 (Act No. 10 of 2013), read with Item 16(6)(a) and (b) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, and after consultation with the Judicial Service Commission, hereby with effect from 1 July 2026 and as indicated in the Schedule-
- (a) withdraw Government Notice No. 1266 published in Government Gazette No. 39540, dated 21 December 2015, determining the areas under jurisdiction of the Limpopo Division of the High Court and establishing the Lephalale Magistrate's Court as the local seat of the Division;
 - (b) withdraw Government Notice No. 408 published in Government Gazette No. 41552, dated 29 March 2018, determining the areas under the jurisdiction of the Gauteng and North West Divisions of the High Court;
 - (c) withdraw Government Notice No. 615 published in Government Gazette No. 42420, dated 26 April 2019, determining the areas under the jurisdiction of the Mpumalanga Division of the High Court;
 - (d) determine, the areas under jurisdiction of the main seats mentioned under Column "B", of the Divisions mentioned under Column "A", as described under Column "D" of the Schedule; and, -
 - (e) determine the areas under jurisdiction of the local seats mentioned under Column "C" of the Divisions mentioned under Column "A" as described under Column "D" of the Schedule.
2. Despite the publication of this Notice and the withdrawal of the Government Notices to in paragraph 1(a)(b) and (c) above, proceedings which have already been placed on the court roll for trial, but have not been concluded before the coming into effect of this Notice, must be concluded as if this Notice has not been published. described under Column "D" of the Schedule.
