**PROCLAMATION NOTICE 327 OF 2026  
by the  
PRESIDENT of the REPUBLIC of SOUTH AFRICA****SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): AMENDMENT OF PROCLAMATION NO. R. 183 OF 2024**

Under section 2(4) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby amend Proclamation 183 of 2024 (hereinafter referred to as “the original Proclamation”) (as published in *Government Gazette* number 51206 dated 13 September 2024)—

- (a) by the extension of the period referred to in the fourth paragraph of the original Proclamation to the date of publication of this proclamation; and
- (b) by the substitution for paragraph 1(e) of the Schedule to the original Proclamation of the following paragraph:
  - “(e) the construction of Nkanini Indoor Sports centre, in terms of Tender Number: UMZ-48T-2014 (Phase 1) and Tender Number: UMZ-65T-2015 (Phase 2);”.
