GENERAL AND FURTHER EDUCATION AND TRAINING QUALITY ASSURANCE ACT, 2001 (ACT NO. 58 OF 2001)

APPOINTMENT OF PERSONS TO SERVE ON THE SEVENTH UMALUSI COUNCIL FOR QUALITY ASSURANCE IN GENERAL AND FURTHER EDUCATION AND TRAINING FOR THE PERIOD 8 JUNE 2026 UNTIL 7 JUNE 2030
