NOTICE OF WITHDRAWAL IN TERMS OF THE SECTION 11 A (3) RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994)

WHEREAS, during further investigation in so far as it relates to the land claim pertaining to the property referred to below, the Regional Land Claims Commissioner, has reason to believe that the criteria set out in Section 11 (1) (b) of the Act, has not been met such that there was no community that was dispossessed in terms of section 2(1)(d) of the Act.

WHEREAS a Notice of Intention to Withdraw Government Gazette 32212, Notice No. 495 of 2009 dated 15 May 2009 was published in terms of Section 11A(2) under Government Gazette No. 51500, Notice No.5509, dated 4 November 2024.

THEREFORE Notice is hereby given in terms of Section 11 A (3) of the Restitution of Land Rights Act, 1994 (Act No. 22 of 1994) as amended that the claim for the restitution of land rights lodged on behalf of Impokoma Community which was published in the Government Gazette No.32212 dated 15 May 2009, Notice No.495 of 2009 under reference number KRP 5085 in respect of the properties described hereunder is finally **WITHDRAWN** by Regional Land Claims Commissioner
