NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT, 2008 (ACT NO. 59 OF 2008)**CONSULTATION ON APPLICATIONS RECEIVED FOR THE EXCLUSION OF A WASTE STREAM
OR A PORTION OF A WASTE STREAM FROM THE DEFINITION OF WASTE FOR BENEFICIAL
USE**

I, David Maynier, Minister of Forestry, Fisheries and the Environment, hereby, in terms of regulation 6(3) of the Regulations regarding the exclusion of a waste stream or a portion of a waste stream from the definition of waste, 2018, published under Government Notice No. R.715 in *Government Gazette* No. 41777 of 18 July 2018, read with sections 72 and 73 of the National Environmental Management: Waste Act, 2008 (Act No.59 of 2008), give notice of my intention to take decisions on applications received for the exclusion of a waste stream or a portion of a waste stream from the definition of waste for specified beneficial use, as set out in the Schedule hereto.

In considering these applications, the criteria contemplated in regulation 7, as well as the risk assessment requirements contemplated in regulation 8 of the aforesaid regulations, will be considered. Where a waste stream is excluded from the definition of waste, the applicant will be required to implement and comply with a risk management plan based on the risk assessment, and to submit annual reports to the Department in terms of regulation 10 of the Regulations.

Members of the public are hereby invited to submit written representations or objections to the proposed decisions within thirty (30) days from the date of publication of this notice in the *Government Gazette* or the newspaper, whichever date is the last date, to any of the following addresses:
