PROCLAMATION NOTICE 349 OF 2026

SPECIAL INVESTIGATING UNITS AND SPECIAL TRIBUNALS ACT, 1996 (ACT NO. 74 OF 1996): AMENDMENT OF PROCLAMATION NO. R. 181 OF 2024

Under section 2(4) of the Special Investigating Units and Special Tribunals Act, 1996 (Act No. 74 of 1996), I hereby amend Proclamation 181 of 2024 (hereinafter referred to as "the original Proclamation"), by the—

- (a) extension of the end date mentioned in paragraph 4 of the body of the original Proclamation (13 September 2024, being the date of publication of the original Proclamation) to date of publication of Proclamation;
- (b) deletion in subparagraph (a) of paragraph 1 of "and";
- (c) substitution in subparagraph (b) of paragraph 1 for the comma of "; and"; and
- (d) insertion in paragraph 1 after subparagraph (b) of the following subparagraph:
"(c) 100 ablution and sanitation infrastructure and facilities at Bekkersdal,".
