- 5. If the applicant does not sign the application personally, a letter authorizing the signatory (agent) to sign the application on behalf of the applicant must accompany the application.

If an applicant has entered into an agreement with the foreign supplier of the animal's to be imported, in terms of which royalties, fees or concessions, in addition to the purchase price are payable or to be given in respect of the use of such animal/s or progeny thereof, this application shall also be accompanied by a confirmation by the Director-General of the Department of Trade and Industries that such agreement has been approved by this Department.
