Procedure to apply for a re-issue of an Animal Identification certificate

- Complete full names and surname on the application form (nr 1 & 2)
- Make sure your identity number is written down correctly on the application form. (nr 3)
- only complete this part if you registered the brandmark under a company/trust etc. (nr 4 & 5)
- The street address is the address where the animals are being kept and the postal address must be a working address where the certificate can be posted to. you will pay again if you gave us the wrong address. (nr 6)
- The name of farm is where the animals are kept (also can be the name of the village) (nr 7)
- The Magisterial district is where the nearest court is to your animals. (nr 8)
- The province is where the animals are kept (nr 9)

Further Information

- 1. Application and proof of payment <u>MUST</u> be send together.
- 2. Applications can be faxed, emailed, posted or brought in personally (not all 4 as it would cause unnecessary confusion)
- 3. If your identity number changed over the past 20 years, please indicate such on the application. if you fail to do so a new brandmark will be allocated to you and that will result in a delay in your application.
- 4. Please note that the brandmark section email address for applications has changed to a permanent email animalid@dalrrd.gov.za. DO NOT SEND IT TO ANY OTHER EMAIL
- 5. <u>Please note</u>: it takes 30 working days inside the Department to finalize. (under normal circumstances)
- 6. The mark won't change.
- 7. After the certificate was finalized it will be posted back to you. (the mark will be emailed, not the certificate) (if no email was provided on the form in a neat and readable manner it will only be posted and it will not be emailed at a later stage). And we do not know how long the post take as the post office is not part of our section.
- 8. We work according to a very strict first come first serve principle NO EXCEPTIONS WILL BE MADE.
- 9. Equipment is sold by your local Kooperasie. (for example BKB)
- 10. As soon as certificate has been received you must mark your animals immediately.
- 11. If you make an enquiry about your Animal Identification mark please use your identity number as a reference unless you have applied under a company or trust (in other words if you completed nr 4 and nr 5 on the application form) then please use the name of the company and the company number.
- 12. Enquiries without the above information will not be attended too.
- 13. If no certificate was received by you after 3 Months, please enquire if you fail to do so you will have to re-apply.
